A bill to amend 1949 PA 300, entitled

"Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding sections 217m and 217n.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 217M. (1) THE SECRETARY OF STATE SHALL DEVELOP AND
- 2 ISSUE A "BREAST CANCER TREATMENT" FUND-RAISING PLATE. THE SECRE-
- 3 TARY OF STATE SHALL DESIGN THE PLATE, HAVING THE WORDS "BREAST
- 4 CANCER TREATMENT" INSCRIBED ON THE PLATE. THE WORD "MICHIGAN"
- 5 SHALL APPEAR ON THE PLATE.
- 6 (2) THE OWNER OF A VEHICLE REQUIRED TO BE REGISTERED UNDER
- 7 THIS ACT MAY APPLY, ON A FORM PRESCRIBED BY THE SECRETARY OF
- 8 STATE, FOR A BREAST CANCER TREATMENT REGISTRATION PLATE INSTEAD

- 10 (3) UPON APPLICATION AND PAYMENT OF THE REGULAR REGISTRATION

- 1 OF STATE SHALL ISSUE A BREAST CANCER TREATMENT REGISTRATION PLATE

- 3 (4) THE SECRETARY OF STATE SHALL DEPOSIT THE \$25.00 DONATION

- 1 (B) THE INDIVIDUAL DOES NOT HAVE HEALTH INSURANCE COVERAGE.
- 2 (6) AS USED IN THIS SECTION:
- 3 (A) "FUND" MEANS THE BREAST CANCER TREATMENT FUND CREATED IN
- 4 SUBSECTION (1).
- 5 (B) "UNDERINSURED" MEANS AN INDIVIDUAL WHO IS UNDER A HEALTH
- 6 INSURANCE POLICY THAT DOES NOT COVER THE TREATMENT OF BREAST
- 7 CANCER.
