THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 21766. (1) A nursing home shall execute a written con-
- 2 tract solely with an applicant or patient or that applicant's or
- 3 patient's quardian or legal representative authorized by law to
- 4 have access to those portions of the patient's or applicant's
- 5 income or assets available to pay for nursing home care, at each
- 6 of the following times:
- 7 (a) At the time an individual is admitted to a nursing
- 8 home.
- (b) At the expiration of the term of a previous contract.

- 1 (c) At the time the source of payment for the patient's care
- 2 changes.
- 3 (2) A nursing home shall not discharge or transfer a patient
- 4 at the expiration of the term of a contract, except as provided
- **5** in section 21773.
- 6 (3) A NURSING HOME SHALL SPECIFICALLY NOTIFY IN WRITING AN
- 7 APPLICANT OR PATIENT OR THAT APPLICANT'S OR PATIENT'S GUARDIAN OR
- 8 LEGAL REPRESENTATIVE OF THE AVAILABILITY OR LACK OF AVAILABILITY
- 9 OF HOSPICE CARE IN THE NURSING HOME. THIS WRITTEN NOTICE SHALL
- 10 BE BY WAY OF A SPECIFIC PARAGRAPH LOCATED IN THE WRITTEN CONTRACT
- 11 DESCRIBED IN SUBSECTION (1) AND SHALL REQUIRE THE APPLICANT OR
- 12 PATIENT OR THAT APPLICANT'S OR PATIENT'S GUARDIAN OR LEGAL REPRE-
- 13 SENTATIVE TO SIGN OR INITIAL THE PARAGRAPH BEFORE EXECUTION OF
- 14 THE WRITTEN CONTRACT. FAILURE OF THE NURSING HOME TO SUBSTAN-
- 15 TIALLY COMPLY WITH THE REQUIREMENT IMPOSED UNDER THIS SUBSECTION
- 16 RENDERS THE WRITTEN CONTRACT VOIDABLE AT THE OPTION OF THE
- 17 PATIENT OR THE PATIENT'S GUARDIAN OR LEGAL REPRESENTATIVE. AS
- 18 USED IN THIS SUBSECTION, "HOSPICE" MEANS THAT TERM AS DEFINED IN
- **19** SECTION 20106(4).
- 20 (4) $\overline{(3)}$ A nursing home shall provide a copy of the con-
- 21 tract to the patient, the patient's representative, or the
- 22 patient's legal representative or legal guardian at the time the
- 23 contract is executed.
- 24 (5) $\frac{(4)}{(4)}$ For a patient supported by funds other than the
- 25 patient's own funds, a nursing home shall make a copy of the con-
- 26 tract available to the person providing the funds for the
- 27 patient's support.

- 1 (6) $\overline{(5)}$ For a patient whose care is reimbursed with public
- 2 funds administered by the department of social services
- 3 COMMUNITY HEALTH, a nursing home shall maintain a copy of the
- 4 contract in the patient's file at the nursing home and upon
- 5 request shall make a copy of the contract available to the
- 6 department of social services COMMUNITY HEALTH.
- 7 (7) $\overline{(6)}$ The nursing home shall ensure that the contract is
- 8 written in clear and unambiguous language and is printed in not
- 9 less than 12-point type. The form of the contract shall be pre-
- 10 scribed by the department.
- 11 (8) $\overline{(7)}$ The contract shall specify all of the following:
- 12 (a) The term of the contract AND THE ABILITY OF THE PATIENT
- 13 OR THE PATIENT'S GUARDIAN OR LEGAL REPRESENTATIVE TO VOID THE
- 14 CONTRACT UNDER SPECIFIC CIRCUMSTANCES.
- 15 (b) The services to be provided under the contract, INCLUD-
- 16 ING THE AVAILABILITY OF HOSPICE OR OTHER SPECIAL CARE, and the
- 17 charges for the services.
- 18 (c) The services that may be provided to supplement the con-
- 19 tract and the charges for the services.
- 20 (d) The sources liable for payments due under the contract.
- 21 (e) The amount of deposit paid and the general and foresee-
- 22 able terms upon which the deposit will be held and refunded.
- 23 (f) The rights, duties, and obligations of the patient,
- 24 except that the specification of a patient's rights may be fur-
- 25 nished on a separate document that complies with the requirements
- 26 of section 20201.

- 1 (9) $\frac{(8)}{(8)}$ The nursing home may require a patient's or
- 2 applicant's guardian or legal representative who is authorized by
- 3 law to have access to those portions of the patient's or
- 4 applicant's income or assets available to pay for nursing home
- 5 care to sign a contract without incurring personal financial
- 6 liability other than for funds received in his or her legal
- 7 capacity on behalf of the patient.
- 8 (10) $\frac{(9)}{}$ A nursing home employee may request the appoint-
- 9 ment of a guardian for an individual applicant or patient only if
- 10 the nursing home employee reasonably believes that the individual
- 11 meets the legal requirements for the appointment of a guardian.
- 12 Enacting section 1. This amendatory act takes effect
