THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 PART 186. CONTACT LENS PROVIDERS
- 2 SEC. 18601. (1) AS USED IN THIS PART:
- 3 (A) "BUSINESS DAY" MEANS A DAY OF THE YEAR EXCLUSIVE OF A
- 4 SATURDAY, SUNDAY, OR LEGAL HOLIDAY.
- 5 (B) "CONTACT LENS PRESCRIPTION" MEANS A WRITTEN, SIGNED, AND
- 6 DATED ORDER, AS DESCRIBED IN SECTION 18605, BY A PHYSICIAN OR
- 7 OPTOMETRIST DESCRIBING OPTICAL AND PHYSICAL CHARACTERISTICS OF
- 8 CONTACT LENSES TO BE DISPENSED.
- 9 (C) "CONTACT LENS PROVIDER" MEANS A PERSON, WHETHER LOCATED
- 10 WITHIN OR OUTSIDE OF MICHIGAN, WHO DISPENSES, SELLS, OR PROVIDES
- 11 CONTACT LENSES TO A MICHIGAN RESIDENT.

- 23 (C) THE TELEPHONE NUMBER OF THE CONTACT LENS PROVIDER.
- 24 (D) IF THE CONTACT LENS PROVIDER IS NOT LOCATED IN THIS
- 25 STATE, THE NAME OF A RESIDENT AGENT IN THIS STATE FOR ACCEPTANCE
- 26 OF SERVICE OF PROCESS.

- 1 (E) A DECLARATION THAT THE CONTACT LENS PROVIDER WILL COMPLY
- 2 WITH ALL APPLICABLE LAWS AND REGULATIONS IN THE CONDUCT OF ITS
- 3 BUSINESS IN MICHIGAN.
- 4 (2) A PHYSICIAN OR OPTOMETRIST IS NOT REQUIRED TO REGISTER
- 5 UNDER SUBSECTION (1) UNTIL HIS OR HER NEXT LICENSE RENEWAL DATE
- 6 THAT IMMEDIATELY FOLLOWS THE EFFECTIVE DATE OF THIS SECTION.
- 7 (3) THE DEPARTMENT SHALL REGISTER A CONTACT LENS PROVIDER
- 8 UPON PROPER APPLICATION UNDER SUBSECTION (1) AND PAYMENT OF A
- 9 \$20.00 FEE.
- 10 (4) A CONTACT LENS PROVIDER REGISTRATION SHALL BE RENEWED
- 11 EVERY 2 YEARS UPON APPLICATION TO THE DEPARTMENT AND PAYMENT OF A
- **12** \$30.00 RENEWAL FEE.
- 13 (5) THIS SECTION DOES NOT APPLY TO A PHARMACIST LICENSED
- 14 UNDER THIS ARTICLE.
