November 29, 2001, Introduced by Reps. Koetje, Kuipers, Sheltroun, Jelinek, Birkholz, Bisbee, Julian, Scranton, Mead and Neumann and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"

by 2000 PA 279.

CHAPTER XVII
