A bill to amend 1943 PA 240, entitled "State employees' retirement act,"

(MCL 38.1 to 38.69) by adding section 18a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 18A. (1) BEGINNING ON THE EFFECTIVE DATE OF THIS SEC-
- 2 TION, THE RETIREMENT SYSTEM SHALL NOT PAY A RETIREMENT ALLOWANCE
- 3 TO A MEMBER OR DEFERRED MEMBER WHO BECOMES ELIGIBLE FOR A RETIRE-
- 4 MENT ALLOWANCE WHILE THAT INDIVIDUAL IS A STATE SENATOR OR STATE
- 5 REPRESENTATIVE. THE RETIREMENT SYSTEM SHALL BEGIN PAYMENT OF A
- 6 RETIREMENT ALLOWANCE NOT PAID UNDER THIS SUBSECTION ON THE FIRST
- 7 DAY OF THE CALENDAR MONTH THAT FOLLOWS THE DATE THE INDIVIDUAL NO
- 8 LONGER HOLDS THE OFFICE OF STATE SENATOR OR STATE
- 9 REPRESENTATIVE. THE RETIREMENT SYSTEM SHALL BEGIN PAYMENT OF THE
- 10 RETIREMENT ALLOWANCE WITHOUT CHANGE IN AMOUNT OR CONDITIONS AS
- 11 OTHERWISE PRESCRIBED IN THIS ACT.

- 18 ELIGIBLE FOR THE BENEFITS DESCRIBED IN THIS SUBSECTION WHEN HIS
- 19 OR HER RETIREMENT ALLOWANCE IS PAYABLE UNDER SUBSECTION (1) OR

- 21 (4) AS A CONDITION OF RECEIVING A RETIREMENT ALLOWANCE UNDER
- 22 THIS ACT, A MEMBER, DEFERRED MEMBER, OR RETIRANT SHALL NOTIFY THE
- 23 RETIREMENT SYSTEM IF HE OR SHE BECOMES A STATE SENATOR OR STATE
- 24 REPRESENTATIVE. A MEMBER, DEFERRED MEMBER, OR RETIRANT WHO FAILS
- 25 TO NOTIFY THE RETIREMENT SYSTEM OF BECOMING A STATE SENATOR OR
- 26 STATE REPRESENTATIVE AS REQUIRED UNDER THIS SECTION IS LIABLE TO
- 27 THE RETIREMENT SYSTEM FOR AMOUNTS PAID OR BENEFITS RECEIVED IN

- 1 VIOLATION OF THIS SECTION, INCLUDING INTEREST ON THOSE AMOUNTS AS
- 2 DETERMINED BY THE RETIREMENT BOARD.
