May 29, 2001, Introduced by Senators HART, MC MANUS, MURPHY, CHERRY and PETERS  
and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 16r of chapter XVII (MCL 777.16r), as amended  
by 2000 PA 279.

1 CHAPTER XVII
