- 2 ENTRY DATABASE FOR THE PURPOSE OF REQUIRING TERMINAL OPERATORS
- 3 AND RETAIL GASOLINE STATIONS TO IMMEDIATELY REPORT PRICE CHANGES
- 4 OF GASOLINE AND DIESEL FUEL. THE DATABASE SHALL INCLUDE A
- 5 MONTHLY REPORT OF THE RESPECTIVE PRICES OF THE OIL COMPANIES
- 6 OPERATING GASOLINE STATIONS IN THIS STATE AND A COMPARISON OF THE
- 7 INCREASE OR DECREASE IN THE WHOLESALE AND RETAIL PRICES FOR THAT
- 8 MONTH AND FOR THE IMMEDIATELY PRECEDING 2 MONTHS AND INFORMATION
- 9 RELATING TO PRICE LEADERSHIP BY CERTAIN COMPANIES WITHIN CERTAIN
- 10 GEOGRAPHIC REGIONS WITHIN THIS STATE. THE DEPARTMENT SHALL
- 11 ANNUALLY PROVIDE AN ANALYSIS OF THE DATA WITH RECOMMENDATIONS AS
