## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1290. (1) For the 2003-2004 school year, if a school

- 6 all of grades K-3 shall ensure that the average class size in
- 7 grades K-3 is not more than 17 pupils per class, with not more
- 8 than 19 pupils in any particular class.
- 9 (6) For the purposes of this section, free lunch eligibility
- 10 shall be as determined under the Richard B. Russell national

- 14 October 31 of the immediately preceding school year and adjusted
