

HOUSE BILL No. 4469

March 27, 2003, Introduced by Reps. Nofs, Van Regenmorter, Vander Veen and Voorhees and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16g of chapter XVII (MCL 777.16g), as amended by 2002 PA 630.
