

HOUSE BILL No. 4475

March 27, 2003, Introduced by Reps. Tobocman, Smith, Accavitti, Bieda, Wojno, Kooiman, Sak, Hood, Rivet, Gleason, Meisner and Gielegthem and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16d of chapter XVII (MCL 777.16d), as amended
by 2002 PA 269.

CHAPTER XVII
