

HOUSE BILL No. 5952

May 27, 2004, Introduced by Reps. Wenke, Howell, Newell, Nofs, Hune, Gaffney, Meyer, Stahl and Stakoe and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 12d of chapter XVII (MCL 777.12d), as amended by 2002 PA 127.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

CHAPTER XVII

Sec. 12d. This chapter applies to the following felonies enumerated in chapters III, IV, and V of the Michigan vehicle code, 1949 PA 300, within chapter 257 of the Michigan Compiled
