SENATE BILL No. 987

February 12, 2004, Introduced by Senators PATTERSON, KUIPERS, GOSCHKA, LELAND, SCHAUER and HARDIMAN and referred to the Committee on Health Policy.

A bill to amend 1974 PA 369, entitled

"An act to regulate the business of conducting a driver training school; to require licenses in relation thereto; to prescribe certain fees; to prescribe the powers and duties of certain persons and state departments; and to prescribe remedies and penalties,"

by amending section 5 (MCL 256.605), as amended by 2000 PA 285.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 5. (1) A driver training school licensee shall not
- 2 employ a person as an instructor unless the person is licensed as
- 3 an instructor.
- (2) A driver training school licensee shall annually file an
- 5 application with the department for licensing of its employees as
- instructors. For each employee for which licensure as an
- 7 instructor is sought, the application shall include all of the
- 8 following:
 - (a) The name and address of the employee.

- 1 (b) The driver's license number of the employee. An
- 2 application for a nonresident employee shall also include a
- 3 certified copy of his or her driving record from his or her state
- 4 of residence.
- 5 (c) A dated medical examination report that is not more than
- 6 2 years old and is completed by a physician or a certified nurse
- 7 practitioner licensed to practice in this state. An application
- 8 for a nonresident employee fulfills the requirement of this
- 9 subdivision if the application includes a report completed by a
- 10 physician or a certified nurse practitioner licensed to practice
- 11 in the employee's state of residence.
- 12 (d) A fee of \$25.00 for each employee seeking licensure as an
- 13 instructor.
- 14 (e) Except as otherwise provided in section 5b, an
- 15 authorization to be signed by a prospective employee to be hired
- 16 as a driving instructor permitting the licensee to request a
- 17 criminal history check from the department of state police and
- 18 the federal bureau of investigation.
- 19 (3) The department shall issue a license certificate to the
- 20 driver training school licensee for each of its employees who
- 21 meet the requirements of this act for licensure as an
- 22 instructor. A license certificate expires on December 31 of the
- 23 year for which it is issued.
- 24 (4) The department may issue a license certificate to an
- 25 applicant for a driving instructor's license after the favorable
- 26 criminal history check from the department of state police, but
- 27 on the condition that the license shall be canceled or revoked if

- 1 the criminal history check from the federal bureau of
- 2 investigation reveals that the applicant does not satisfy the
- 3 qualifications for a license. The department shall immediately
- 4 notify the driver training school licensee, which shall require
- 5 the applicant to surrender the license certificate.
- 6 (5) In order to qualify as an instructor, a person shall meet
- 7 all of the following requirements:
- 8 (a) Be physically able to operate a motor vehicle and to
- 9 train others in the operation of motor vehicles.
- 10 (b) Have a driving record that indicates competence to
- 11 operate a motor vehicle consistent with standards set forth in
- 12 rules promulgated by the secretary of state.
- 13 (c) Be 21 years of age or older on the date the person's
- 14 license application is submitted to the secretary of state.
- 15 (d) Have a driving record, within the 5 years immediately
- 16 preceding submission of an instructor license application to the
- 17 secretary of state, that does not contain a conviction for any
- 18 violation for which 4 or 6 points are assessed, other than points
- 19 assessed for a violation of a speeding law or ordinance, pursuant
- 20 to section 320a of the Michigan vehicle code, 1949 PA 300,
- 21 MCL 257.320a. This subdivision only applies to an applicant who
- 22 was not licensed as a driver training school instructor on
- 23 October 1, 1992.
- (e) Not have a prior felony or misdemeanor conviction for
- 25 criminal sexual conduct pursuant to sections 520b to 520g of the
- 26 Michigan penal code, 1931 PA 328, MCL 750.520b to 750.520q, or a
- 27 felony conviction for a crime in which an element of the crime is
