September 9, 2004, Introduced by Senators McMANUS and BARCIA and referred to the Committee on Appropriations.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 3122 (MCL 324.3122), as added by 2004 PA 90, and by adding section 3123a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3122. (1) Until October 1, 2007, the department may
- 2 levy and collect an annual groundwater discharge permit fee from
- 3 facilities that discharge wastewater to the ground or groundwater
- 4 of this state pursuant to section 3112. The Except as provided
- 5 in section 3123a, the fee shall be as follows:
 - (a) For a group 1 facility, \$3,650.00.
 - (b) For a group 2 facility or a municipality of 1,000 or

 - (c) For a group 3 facility, \$200.00.
 - (2) Within 180 days after receipt of a complete application,

- 2 (2) The director shall make a decision on a petition
- 3 submitted under subsection (1) not later than February 15 of the

- 5 of that decision to the petitioner. If the director determines

- 7 warranted, the director shall specify the amount of the reduced
- 8 fee in the notice. The petitioner shall pay the groundwater
