# **HOUSE BILL No. 4381**

#### EXECUTIVE BUDGET BILL

February 23, 2005, Introduced by Rep. Whitmer and referred to the Committee on Appropriations.

A bill to make appropriations for the department of education and certain other purposes relating to education for the fiscal year ending September 30, 2006; to provide for the expenditure of the appropriations; to prescribe the powers and duties of certain state departments, school districts, and other governmental bodies; and to provide for the disposition of fees and other income received by certain legal entities and state agencies.

3	GENERAL SECTIONS
4	Sec. 201. Pursuant to section 30 of article IX of the state
5	constitution of 1963, total state spending from state resources
6	under part 1 for fiscal year 2005-2006 is \$51,279,800.00 and state
7	spending from state resources to be paid to local units of
8	government for fiscal year 2005-2006 is estimated at
9	\$11,242,000.00. The itemized statement below identifies
10	appropriations from which spending to units of local government

17	Sec. 202. The appropriations authorized under this bill are
18	subject to the management and budget act, 1984 PA 431, MCL 18.1101
19	to 18.1594.
20	Sec. 203. As used in this bill:
21	(a) "Department" means the Michigan department of education.
22	(b) "District" means a local school district as defined in
23	section 6 of the revised school code, 1976 PA 451, MCL 380.6, or a
24	local act school district or public school academy as defined in
25	section 5 of the revised school code, 1976 PA 451, MCL 380.5.

- 1 (c) "FTE" means full-time equated.
- 2 (d) "ISD" means intermediate school district.
- 3 Sec. 204. The department of civil service shall bill
- 4 departments and agencies at the end of the first fiscal quarter for
- 5 the 1% charge authorized by section 5 of article XI of the state
- 6 constitution of 1963. Payments shall be made for the total amount
- 7 of the billing by the end of the second fiscal quarter.
- 8 Sec. 205. Unless otherwise specified, the department shall use
- 9 the Internet to fulfill the reporting requirements of this bill.
- 10 This requirement may include transmission of reports via electronic
- 11 mail to the recipients identified for each reporting requirement,
- 12 or it may include placement of reports on an Internet or Intranet
- **13** site.
- 14 Sec. 206. (1) In addition to the funds appropriated in part 1,
- 15 there is appropriated an amount not to exceed \$20,000,000.00 for
- 16 federal contingency funds. These funds are not available for
- 17 expenditure until they have been transferred to another line item
- 18 in this bill under section 393(2) of the department of management
- 19 and budget act, 1984 PA 431, MCL 18.1393.
- 20 (2) In addition to the funds appropriated in part 1, there is
- 21 appropriated an amount not to exceed \$700,000.00 for state
- 22 restricted contingency funds. These funds are not available for
- 23 expenditure until they have been transferred to another line item
- 24 in this bill under section 393(2) of the department of management
- 25 and budget act, 1984 PA 431, MCL 18.1393.
- 26 (3) In addition to the funds appropriated in part 1, there is
- 27 appropriated an amount not to exceed \$3,000,000.00 for local

- 1 contingency funds. These funds are not available for expenditure
- 2 until they have been transferred to another line item in this bill
- 3 under section 393(2) of the department of management and budget
- 4 act, 1984 PA 431, MCL 18.1393.
- 5 (4) In addition to the funds appropriated in part 1, there is
- 6 appropriated an amount not to exceed \$250,000.00 for private
- 7 contingency funds. These funds are not available for expenditure
- 8 until they have been transferred to another line item in this bill
- 9 under section 393(2) of the department of management and budget
- 10 act, 1984 PA 431, MCL 18.1393.
- 11 Sec. 207. The department shall provide the state budget
- 12 director and the senate and house fiscal agencies with copies of
- 13 the state board of education agenda and all supporting documents at
- 14 the time the agenda and supporting documents are provided to state
- 15 board of education members.
- Sec. 208. (1) Upon receipt of the federal drug free grant, the
- 17 department shall allocate \$225,000.00 of the grant to the safe
- 18 school program within the department. The safe school program
- 19 shall work with local school boards, parents of enrolled students,
- 20 law enforcement agencies, community leaders, and the office of drug
- 21 control policy for the prevention of school violence. The safe
- 22 school program shall develop and implement, and serve as
- 23 coordinator of, a statewide clearinghouse for information, program
- 24 development, model programs and policies, and technical assistance
- 25 on school violence prevention.
- 26 (2) To accomplish its functions under this section, the safe
- 27 school program shall do all of the following:

- 1 (a) Coordinate with the office of drug control policy in the
- 2 department of community health to ensure that there is a meaningful
- 3 linkage between the efforts under this bill to provide safe schools
- 4 and the initiatives undertaken through that office, including, but
- 5 not limited to, school districts' safe and drug-free school plans,
- 6 and to facilitate timely applications for and distribution of
- 7 available grant money.
- 8 (b) Provide through the Internet the availability to and
- 9 information regarding the state model policy on locker searches,
- 10 the state model policy on firearm safety and awareness, and any
- 11 other state or local safety policies that the office considers
- 12 exemplary.
- 13 (c) Advance, promote, and encourage the awareness and use of
- 14 the state police antiviolence hotline.
- 15 Sec. 209. The department shall require all public school
- 16 districts to maintain complete records within the personnel file of
- 17 a teacher or school employee of any disciplinary actions taken by
- 18 the local school board against the teacher or employee for sexual
- 19 misconduct. The records shall not be destroyed or removed from the
- 20 teacher's or employee's personnel file except as required by a
- 21 court order.
- 22 Sec. 210. From the funds appropriated in part 1 for information
- 23 technology, departments and agencies shall pay user fees to the
- 24 department of information technology for technology-related
- 25 services and projects. Such user fees shall be subject to
- 26 provisions of an interagency agreement between the departments and
- 27 agencies and the department of information technology.

- 1 Sec. 211. Amounts appropriated in part 1 for information
- 2 technology may be designated as work projects and carried forward
- 3 to support technology projects under the direction of the
- 4 department of information technology. Funds designated in this
- 5 manner are not available for expenditure until approved as work
- 6 projects under section 451a of the management and budget act, 1984
- **7** PA 431, MCL 18.1451a.
- 8 Sec. 212. Before publishing a list of schools or districts
- 9 determined to have failed to make adequate yearly progress as
- 10 required by the federal no child left behind act of 2001, Public
- 11 Law 107-110, 115 Stat. 1425, the department shall allow a school or
- 12 district to appeal that determination. The department shall
- 13 consider and act upon the appeal within 30 days after it is
- 14 submitted and shall not publish the list until after all appeals
- 15 have been considered and decided.
- 16 Sec. 213. Funds appropriated in part 1 shall not be used for
- 17 the purchase of foreign goods or services, or both, if
- 18 competitively priced and of comparable quality American goods or
- 19 services, or both, are available. Preference should be given to
- 20 goods or services, or both, manufactured or provided by Michigan
- 21 businesses if they are competitively priced and of comparable
- 22 quality.
- Sec. 214. (1) A hiring freeze is imposed on the state
- 24 classified civil service. State departments and agencies are
- 25 prohibited from hiring any new full-time state classified civil
- 26 service employees and prohibited from filling any vacant state
- 27 classified civil service positions. This hiring freeze does not

- 1 apply to internal transfers of classified employees from 1 position
- 2 to another within a department.
- 3 (2) The state budget director may grant exceptions to this
- 4 hiring freeze when the state budget director believes that the
- 5 hiring freeze will result in rendering a state department or agency
- 6 unable to deliver basic services, cause loss of revenue to the
- 7 state, result in the inability of the state to receive federal
- 8 funds, or necessitate additional expenditures that exceed any
- 9 savings from maintaining a vacancy. The state budget director
- 10 shall report quarterly to the chairpersons of the senate and house
- 11 of representatives standing committees on appropriations the number
- 12 of exceptions to the hiring freeze approved during the previous
- 13 quarter and the reasons to justify the exception.
- 14 Sec. 215. (1) Due to the current budgetary problems in this
- 15 state, out-of-state travel for the fiscal year ending September 30,
- 16 2006 shall be limited to situations in which 1 or more of the
- 17 following conditions apply:
- 18 (a) The travel is required by legal mandate or court order or
- 19 for law enforcement purposes.
- 20 (b) The travel is necessary to protect the health or safety of
- 21 Michigan citizens or visitors or to assist other states in similar
- 22 circumstances.
- 23 (c) The travel is necessary to produce budgetary savings or to
- 24 increase state revenues, including protecting existing federal
- 25 funds or securing additional federal funds.
- 26 (d) The travel is necessary to comply with federal
- 27 requirements.

- 1 (e) The travel is necessary to secure specialized training for
- 2 staff that is not available within this state.
- 3 (f) The travel is financed entirely by federal or nonstate
- 4 funds.
- 5 (2) If out-of-state travel is necessary but does not meet 1 or
- 6 more of the conditions in subsection (1), the state budget director
- 7 may grant an exception to allow the travel. Any exceptions granted
- 8 by the state budget director shall be reported on a monthly basis
- 9 to the senate and house of representatives standing committees on
- 10 appropriations.
- 11 (3) Not later than January 1 of each year, each department shall
- 12 prepare a travel report listing all travel by classified and
- 13 unclassified employees outside this state in the immediately
- 14 preceding fiscal year that was funded in whole or in part with
- 15 funds appropriated in the department's budget. The report shall be
- 16 submitted to the chairs and members of the senate and house of
- 17 representatives standing committees on appropriations, the fiscal
- 18 agencies, and the state budget director. The report shall include
- 19 the following information:
- 20 (a) The name of each person receiving reimbursement for travel
- 21 outside this state or whose travel costs were paid by this state.
- 22 (b) The destination of each travel occurrence.
- (c) The dates of each travel occurrence.
- 24 (d) A brief statement of the reason for each travel occurrence.
- 25 (e) The transportation and related costs of each travel
- 26 occurrence, including the proportion funded with state general
- 27 fund/general purpose revenues, the proportion funded with state

- 1 restricted revenues, the proportion funded with federal revenues,
- 2 and the proportion funded with other revenues.
- 3 (f) A total of all out-of-state travel funded for the
- 4 immediately preceding fiscal year.
- 5 Sec. 216. The director shall take all reasonable steps to
- 6 ensure businesses in deprived and depressed communities compete for
- 7 and perform contracts to provide services or supplies, or both.
- 8 The director shall strongly encourage firms with which the
- 9 department contracts to subcontract with certified businesses in
- 10 depressed and deprived communities for services, supplies, or both.

#### 11 STATE BOARD/OFFICE OF THE SUPERINTENDENT

- Sec. 301. (1) The appropriations in part 1 may be used for per
- 13 diem payments to the state board for meetings at which a quorum is
- 14 present or for performing official business authorized by the state
- 15 board. The per diem payments shall be at a rate as follows:
- 16 (a) State board of education president \$110.00 per day.
- 17 (b) State board of education member other than president -
- **18** \$100.00 per day.
- 19 (2) A state board of education member shall not be paid a per
- 20 diem for more than 30 days per year.
- 21 (3) The administrative secretary of the state board of education
- 22 shall report to the public, the senate and house fiscal agencies,
- 23 and the state budget director the previous quarter's expenses by
- 24 fund source for members of the state board of education.
- 25 Sec. 302. From the amount appropriated in part 1 to the state
- 26 board of education, not more than \$35,000.00 shall be expended for
- 27 travel.

## 1 MICHIGAN SCHOOLS FOR THE DEAF AND BLIND

- 2 Sec. 401. The employees at the Michigan schools for the deaf
- 3 and blind who work on a school year basis shall be considered
- 4 annual employees for purposes of service credits, retirement, and
- 5 insurance benefits.
- 6 Sec. 402. For each student enrolled at the Michigan schools for
- 7 the deaf and blind, the department shall assess the intermediate
- 8 school district of residence 100% of the cost of operating the
- 9 student's instructional program. The amount shall exclude room and
- 10 board related costs and the cost of weekend transportation between
- 11 the school and the student's home.
- Sec. 403. (1) The department may assess rent to any state
- 13 agency for the use of any facility at the Michigan school for the
- 14 blind's former site in Lansing. The rental rates and all leasing
- 15 arrangements shall be subject to the approval of the department of
- 16 management and budget.
- 17 (2) In addition to those funds appropriated in part 1, the
- 18 department may receive and expend additional funds from lease
- 19 agreements at the Michigan school for the blind's former site in
- 20 Lansing that have been negotiated with the approval of the
- 21 department of management and budget. These funds are appropriated
- 22 to the department for operation, maintenance, and renovation
- 23 expenses associated with the leased space designated in the
- 24 tenant's lease agreement.
- 25 (3) Security guards or other patrols at the Michigan school for
- 26 the blind's former site shall not be funded through part 1 funds
- 27 appropriated for the Michigan schools for the deaf and blind.

- 1 (4) If the department leases real property to a person or
- 2 organization that is not a department of state government, the
- 3 department shall not expend funds in excess of the lease revenue
- 4 received to replace, renovate, or repair that real property. This
- 5 section shall not apply to emergency repairs or costs associated
- 6 with technological renovations.
- 7 (5) The department shall not lease real property for less than
- 8 fair market value.
- **9** (6) From the unexpended balances of appropriations for the
- 10 former school for the blind site in Lansing, up to \$100,000.00 of
- 11 any unexpended and unencumbered funds remaining on September 30,
- 12 2006 may be carried forward as a work project and expended for
- 13 special maintenance and repairs of facilities at the former
- 14 Michigan school for the blind site in Lansing. The work project
- 15 shall be performed by state employees or by contract when necessary
- 16 at an estimated cost of \$100,000.00. The estimated completion date
- 17 of the work project is September 30, 2007.
- 18 Sec. 404. (1) The department may assess rent or lease excess
- 19 property located on the campus of the Michigan schools for the deaf
- 20 and blind in Flint to private or publicly funded organizations.
- 21 (2) In addition to those funds appropriated in part 1, the
- 22 department may receive and expend additional funds from lease
- 23 agreements at the Michigan schools for the deaf and blind Flint
- 24 campus that have been negotiated with the approval of the
- 25 department of management and budget. These funds are appropriated
- 26 to the department for the operation, maintenance, and renovation
- 27 expenses associated with the leased space.

- 1 (3) From the unexpended balances of appropriations for the
- 2 schools for the deaf and blind operations, up to \$250,000.00 of any
- 3 unexpended and unencumbered funds remaining on September 30, 2006
- 4 may be carried forward as a work project and expended for special
- 5 maintenance and repairs of facilities at the campus of the Michigan
- 6 schools for the deaf and blind in Flint. The work shall be carried
- 7 out by state employees, or by contract as necessary, at an
- 8 estimated cost of \$250,000.00. The estimated completion date of
- 9 the work is September 30, 2007.
- 10 Sec. 407. The department may assist the department of community
- 11 health, other departments, and local school districts to secure
- 12 reimbursement for eligible services provided in Michigan schools
- 13 from the federal Medicaid program. The department may submit
- 14 reports of direct expenses related to this effort to the department
- 15 of community health for reimbursement.
- 16 Sec. 408. (1) The Michigan schools for the deaf and blind may
- 17 promote its residential program as a possible appropriate option
- 18 for children who are deaf or hard of hearing or who are blind or
- 19 visually impaired. The Michigan schools for the deaf and blind
- 20 shall distribute information detailing its services to all
- 21 intermediate school districts in the state.
- 22 (2) Upon knowledge of or recognition by an intermediate school
- 23 district that a child in the district is deaf or hard of hearing or
- 24 blind or visually impaired, the intermediate school district shall
- 25 provide to the parents of the child the literature distributed by
- 26 the Michigan schools for the deaf and blind to intermediate school
- 27 districts under subsection (1).

- 1 (3) Parents should continue to have a choice regarding the
- 2 educational placement of their deaf or hard of hearing children.
- 3 Sec. 409. In addition to those funds appropriated in part 1,
- 4 the department may receive and expend funds from the mid-Michigan
- 5 leadership academy for capital improvements. The department shall
- 6 report to the house and senate fiscal agencies and the state budget
- 7 office on an annual basis any expenditures made under this section.
- 8 These additional funds are appropriated specifically for capital
- 9 improvements authorized by the department of management and budget
- 10 and shall be negotiated as part of the lease agreement.

#### 11 PROFESSIONAL PREPARATION SERVICES

- 12 Sec. 501. From the funds appropriated in part 1 for
- 13 professional preparation services, the department shall maintain
- 14 the professional personnel register and certificate
- 15 revocation/felony conviction files.
- Sec. 502. The department shall authorize teacher preparation
- 17 institutions to provide an alternative program by which up to 1/2
- 18 of the required student internship or student teaching credits may
- 19 be earned through substitute teaching. The department shall
- 20 require that teacher preparation institutions collaborate with
- 21 school districts to ensure that the quality of instruction provided
- 22 to student teachers is comparable to that required in a traditional
- 23 student teaching program.

#### 24 OFFICE OF SCHOOL IMPROVEMENT

- 25 Sec. 601. From the amount appropriated in part 1 for the office
- of school improvement, there is allocated \$350,000.00 and 3.5 FTE
- 27 positions to operate a charter school office to administer charter

- 1 school legislation and associated regulations, and to coordinate
- 2 the activities of the department relating to charter schools.

#### 3 GRANTS AND DISTRIBUTIONS

- 4 Sec. 701. The department shall disburse the funds to a general
- 5 fund grantee in accordance with the same standards of timing and
- 6 amount that apply to disbursements made by the department to a
- 7 federal fund grantee. The disbursement shall be restricted to the
- 8 minimum amount needed for immediate disbursement by the grantee.
- 9 The department may waive this section if extenuating circumstances
- 10 warrant and are substantiated in the grantee's application or other
- 11 appropriate documentation. A waiver granted pursuant to this
- 12 section shall not be effective until 15 days after written notice
- 13 of the proposed waiver is given to the state budget director and
- 14 the chairpersons of the senate and house appropriations
- 15 subcommittees having jurisdiction over the department budget.
- 16 Sec. 702. The funds appropriated in part 1 for school breakfast
- 17 programs shall be made available to all eligible applicant public
- 18 school districts as follows:
- 19 (a) The public school district participates in the federal
- 20 school breakfast program and meets all standards as prescribed by 7
- **21** CFR parts 220 and 245.
- 22 (b) Payment is made for each breakfast served meeting standards
- 23 prescribed in subdivision (a).
- 24 (c) The payment for a public school district is at a per meal
- 25 rate equal to the lesser of the district's actual cost, or 100% of
- 26 the cost of a breakfast served by an efficiently operated breakfast
- 27 program as determined by the department, less federal

- 1 reimbursement, participant payments, and other state reimbursement.
- 2 Determination of efficient cost by the department shall be
- 3 determined by using a statistical sampling of statewide and
- 4 regional cost as reported in a manner approved by the department
- 5 for the preceding school year.
- 6 (d) The payment determined under subdivision (c) is prorated if
- 7 the appropriation in part 1 is not sufficient to fund all payments
- 8 determined under this section.
- 9 Sec. 703. (1) The funds appropriated in part 1 for school
- 10 readiness programs shall be made available through a competitive
- 11 application process as follows:
- 12 (a) An applicant may be any public or private nonprofit legal
- 13 entity or agency other than a local or intermediate school district
- 14 except a local or intermediate school district acting as a fiscal
- 15 agent for a child caring organization regulated under 1973 PA 116,
- **16** MCL 722.111 to 722.128.
- 17 (b) Applications shall be submitted in a form and manner as
- 18 required by the department.
- 19 (c) Applications shall be reviewed by a diverse interagency
- 20 committee composed of representatives of the department,
- 21 appropriate community, volunteer, and social service agencies and
- 22 organizations, and parents.
- 23 (d) Priority in the recommendation for awarding of grants by
- 24 the superintendent of public instruction to applicants shall be
- 25 based upon the following criteria:
- 26 (i) Compliance with standards for early childhood development
- 27 consistent with programs for 4-year-olds, as approved by the state

- 1 board of education.
- $\mathbf{2}$  (ii) Active and continuous involvement of the parents or
- 3 guardians of the children participating in the program.
- 4 (iii) Employment of teachers possessing proper training in early
- 5 childhood development, including an early childhood (ZA)
- 6 endorsement or child development associate, and trained support
- 7 staff.
- 8 (iv) Evidence of collaboration with the community of providers
- 9 in early childhood development programs including documentation of
- 10 the total number of children in the community who would meet the
- 11 criteria established in subparagraph (vi), and who are being served
- 12 by other providers, and the number of children who will remain
- 13 unserved by other community early childhood programs if this
- 14 program is funded.
- 15 (v) The extent to which these funds will supplement other
- 16 federal, state, local, or private funds.
- 17 (vi) The extent to which these funds will be targeted to
- 18 children who will be at least 4, but less than 5, years of age as
- 19 of December 1 of the year in which the programs are offered and who
- 20 show evidence of 2 or more "at-risk" factors as defined in the
- 21 state board of education report entitled, "children at risk" that
- was adopted by the state board on April 5, 1988.
- 23 (e) Whether the application contains a comprehensive evaluation
- 24 plan that includes implementation of all program components
- 25 required and an assessment of the gains of children participating
- 26 in an early childhood development program.
- 27 (f) Applications shall provide for the establishment of a

- 1 school readiness advisory committee that shall be involved in the
- 2 planning and evaluation of the program and provides for the
- 3 involvement of parents and appropriate community, volunteer, and
- 4 social service agencies and organizations. There shall be on the
- 5 committee at least 1 parent or guardian of a program participant
- 6 for every 18 children enrolled in the program, with a minimum of 2
- 7 parent or guardian representatives. The committee shall do all of
- 8 the following:
- 9 (i) Review the mechanisms and criteria used to determine
- 10 referrals for participation in the school readiness program.
- (ii) Review the health screening program for all participants.
- 12 (iii) Review the nutritional services provided to all
- 13 participants.
- (iv) Review the mechanisms in place for the referral of families
- 15 to community social service agencies, as appropriate.
- 16 (v) Review the collaboration with and the involvement of
- 17 appropriate community, volunteer, and social service agencies and
- 18 organizations in addressing all aspects of education disadvantage.
- (vi) Review, evaluate, and make recommendations for changes in
- 20 the school readiness program.
- 21 (g) More than 50% of the children participating in the program
- 22 shall meet the income eligibility criteria for free or reduced
- 23 price lunch, as determined under the national school lunch act,
- 24 chapter 281, 60 Stat. 230, 42 USC 1751 to 1753, 1755 to 1761,
- 25 1762a, 1765 to 1766b, and 1769 to 1769h, or meet income and all
- 26 other eligibility criteria for participation in the Michigan family
- 27 independence agency unified child day care program.

- 1 (2) Grant awards by the superintendent of public instruction may
- 2 be at whatever level the superintendent determines appropriate. A
- 3 grant, when combined with other sources of state revenue for this
- 4 program, shall not exceed \$3,300.00 per child or the cost of the
- 5 program, whichever is less.
- 6 (3) Except as otherwise provided, an applicant that received a
- 7 grant under this section in the prior fiscal year, shall also
- 8 receive priority for funding in the next two fiscal years.
- 9 However, after 3 fiscal years of continuous funding, an applicant
- 10 will be required to compete openly with new programs and other
- 11 programs completing their third year. All grant awards are
- 12 contingent on the availability of funds and documented evidence of
- 13 grantee compliance with standards for early childhood development
- 14 consistent with programs for 4-year-olds, as approved by the state
- 15 board of education, and with all operational, fiscal,
- 16 administrative, and other program requirements. A program which
- 17 offers supplementary day care and thereby offers full-day programs
- 18 as part of its early childhood development program shall receive
- 19 priority in the allocation of competitive funds.

#### 20 INFORMATION TECHNOLOGY

- 21 Sec. 801. The department shall work in collaboration with the
- 22 center for educational performance and information to support the
- 23 comprehensive educational information system and all data
- 24 collection efforts of the department.

### 25 EDUCATIONAL ASSESSMENT

- 26 Sec. 901. (1) From the funds appropriated in part 1 for the
- 27 educational assessment operations, the department shall provide

- 1 tests to nonpublic schools and home-schooled students upon request.
- 2 The department shall notify nonpublic schools that they are
- 3 eligible to receive the tests.
- 4 (2) The results of each test administered as part of the
- 5 Michigan educational assessment program, including tests
- 6 administered to high school students, shall include an item
- 7 analysis that lists all items that are counted for individual
- 8 student scores and the percentage of students choosing each
- 9 possible response.
