## **HOUSE BILL No. 4475**

March 9, 2005, Introduced by Reps. Robertson, Caul, Gosselin, David Law, Clack, Kahn and Vander Veen and referred to the Committee on Tax Policy.

A bill to amend 1967 PA 281, entitled

"Income tax act of 1967,"

(MCL 206.1 to 206.532) by adding section 437.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 437. (1) FOR THE 2005 TAX YEAR AND EACH TAX YEAR AFTER
- 2 THE 2005 TAX YEAR, AN INDIVIDUAL MAY DESIGNATE ON HIS OR HER ANNUAL
- 3 RETURN THAT A CONTRIBUTION OF \$2.00 OR MORE OF HIS OR HER REFUND BE
- 4 CREDITED TO THE DEPARTMENT OF COMMUNITY HEALTH FOR CANCER RESEARCH.
- 5 IF AN INDIVIDUAL'S REFUND IS NOT SUFFICIENT TO MAKE A CONTRIBUTION
- 6 UNDER THIS SECTION, THE INDIVIDUAL MAY DESIGNATE A CONTRIBUTION
- 7 AMOUNT AND THAT CONTRIBUTION AMOUNT SHALL BE ADDED TO THE
- 8 INDIVIDUAL'S TAX LIABILITY FOR THE TAX YEAR.
  - (2) THE TAX DESIGNATION AUTHORIZED IN THIS SECTION SHALL BE
