A bill to amend 1943 PA 183, entitled "County zoning act,"

(MCL 125.201 to 125.240) by adding section 16j.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 16J. (1) AS USED IN THIS SECTION, A "WIND ENERGY SYSTEM"
- 2 OR "SYSTEM" MEANS A WIND ENERGY CONVERSION SYSTEM.
- 3 (2) A WIND ENERGY SYSTEM SHALL BE PERMITTED IN ALL ZONING
- 4 CLASSIFICATIONS SUBJECT TO ALL OF THE FOLLOWING REQUIREMENTS:
 - (A) THE WIND ENERGY SYSTEM SHALL BE BUILT AT A DISTANCE FROM
 - ALL PROPERTY LINES NOT LEASED OR OWNED BY THE OWNER OF THE SYSTEM THAT
 - IS NOT LESS THAN THE HEIGHT OF THE SYSTEM TOWER INCLUDING THE TOP OF
- 8 THE BLADE IN ITS VERTICAL POSITION.

- 1 (B) THE MINIMUM VERTICAL CLEARANCE FROM THE BLADE TIP TO THE
- 2 GROUND SHALL NOT BE LESS THAN 20 FEET.
- 3 (C) THE SOUND CREATED BY THE SYSTEM SHALL NOT EXCEED 60 DBA AT
- 4 THE CLOSEST PROPERTY LINE OF PROPERTY NOT SERVED BY THE SYSTEM.
- 5 (D) THE SYSTEM SHALL COMPLY WITH ALL APPLICABLE STATE

- 7 (3) BEFORE A WIND ENERGY SYSTEM IS INSTALLED, THE OWNER OF THE

- 9 OWNER INTENDS TO INSTALL AN INTERCONNECTED WIND ENERGY SYSTEM

- 11 (4) ALL INTERCONNECTED CUSTOMER OWNED WIND ENERGY SYSTEM
- 12 GENERATORS SHALL COMPLY WITH ALL APPLICABLE MICHIGAN PUBLIC SERVICE
- 13 COMMISSION AND ELECTRIC SUPPLIER INTERCONNECTION REQUIREMENTS.
- 14 (5) THE OWNER OF A WIND ENERGY SYSTEM SHALL ESTABLISH AND
- 15 FOLLOW A REGULAR MAINTENANCE PROGRAM.
- 16 (6) THE OWNER OF A WIND ENERGY SYSTEM MAY APPLY TO THE COUNTY
- 17 IN WHICH THE SYSTEM IS LOCATED FOR, AND THE COUNTY MAY GRANT, A
- 18 VARIANCE FROM THE REQUIREMENTS OF THIS SECTION.
- 19 (7) AN OWNER OF A WIND ENERGY SYSTEM SHALL NOT BE FOUND TO BE A
- 20 PUBLIC OR PRIVATE NUISANCE IF THE SYSTEM COMPLIES WITH THE
- 21 REQUIREMENTS OF THIS SECTION. THIS SUBSECTION APPLIES NOTWITHSTANDING
- 22 ANY OF THE FOLLOWING:
- 23 (A) A CHANGE IN OWNERSHIP.
- 24 (B) TEMPORARY CESSATION OR INTERRUPTION IN PRODUCING
- 25 ELECTRICITY BY THE SYSTEM.
- 26 (C) NEW TECHNOLOGY.
