## **HOUSE BILL No. 4786**

May 12, 2005, Introduced by Reps. David Law, Schuitmaker and Nofs and referred to the Committee on Judiciary.

A bill to amend 2003 PA 125, entitled "Local corrections officers training act," by amending section 15 (MCL 791.545).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 15. (1) The local corrections officers training fund is created in the state treasury. The fund shall be administered by the council, which shall expend the fund only as provided in this section.

- (2) There shall be credited to the local corrections officer training fund all revenue received from fees and civil fines collected under section 4b of 1846 RS 171, MCL 801.4b, and funds from any other source provided by law.
  - (3) The council shall use the fund only to defray -the- costs

- 23 shall include the address to which the reimbursement request should
- 24 be sent.
- 25 (5) Unexpended funds remaining in the fund at the end of the
- 26 fiscal year shall remain in the fund and shall not revert to the
- 27 general fund.
