- 1 SEC. 21794. (1) A NURSING HOME MAY USE A DINING ASSISTANT TO

- 7 PARENTERAL FEEDINGS. A DINING ASSISTANT SHALL WORK UNDER THE
- S SUPERVISION OF A REGISTERED PROFESSIONAL NURSE OR A LICENSED

- 7 (C) "SUPERVISION" MEANS A REGISTERED PROFESSIONAL NURSE OR

- 9 ASSISTANT AND COMPLIES WITH EACH OF THE FOLLOWING:
- 10 (i) DESIGNATES A RESIDENT UPON WHOM FEEDING ASSISTANCE IS TO

- 12 (ii) IS PHYSICALLY PRESENT IN THE NURSING HOME AT THE TIME
- 13 ASSISTANCE IS BEING PROVIDED.
