## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 225. (1) SUBJECT TO SUBSECTION (3), A PERSON SHALL NOT
- 2 CHANGE, ALTER, REMOVE, OR OBLITERATE ANY COLORATION OR MARKINGS
- 3 THAT ARE REQUIRED FOR AN IMITATION FIREARM BY ANY APPLICABLE STATE

- 5 LIKE A FIREARM. A PERSON THAT VIOLATES THIS SUBSECTION IS GUILTY OF
- 6 A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 90 DAYS
- 7 OR A FINE OF NOT MORE THAN \$500.00, OR BOTH.

- 14 (C) "IMITATION FIREARM" MEANS A BB GUN, TOY GUN, REPLICA OF A
- 15 FIREARM, OR OTHER DEVICE THAT IS SO SUBSTANTIALLY SIMILAR IN
- 16 COLORATION AND OVERALL APPEARANCE TO AN EXISTING FIREARM AS TO LEAD
- 17 A REASONABLE PERSON TO PERCEIVE THAT THE DEVICE IS A FIREARM.
