1 TITLE

article III.

An act to require persons convicted of certain offenses to register; TO PROHIBIT CERTAIN INDIVIDUALS FROM RESIDING WITHIN A STUDENT SAFETY ZONE; to prescribe the powers and duties of certain departments and agencies in connection with that registration; and to prescribe penalties and sanctions.
