

# HOUSE BILL No. 5051

July 13, 2005, Introduced by Reps. Farrah, Casperson, Accavitti and Gillard and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled  
"Michigan vehicle code,"  
(MCL 257.1 to 257.923) by adding section 312g.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           **SEC. 312G. (1) A PERSON, BEFORE OPERATING A MOTORCYCLE UPON A**  
2           **PUBLIC STREET OR HIGHWAY IN THIS STATE WITHOUT WEARING A CRASH**  
3           **HELMET ON HIS OR HER HEAD, SHALL PROCURE A NO-HELMET ENDORSEMENT ON**  
4           **HIS OR HER OPERATOR'S OR CHAUFFEUR'S LICENSE, WHICH SHALL BE**  
5           **ISSUED, SUSPENDED, REVOKED, CANCELED, OR RENEWED AS PROVIDED IN**  
6           **THIS ACT. AN ENDORSEMENT UNDER THIS SECTION MAY ONLY BE ISSUED TO**  
7           **AN INDIVIDUAL WHO HAS COMPLIED WITH THE REQUIREMENTS OF SECTION 658**  
8           **EXEMPTING THE INDIVIDUAL FROM THE HELMET REQUIREMENT AND SHALL**

1 PRESENT ANY EVIDENCE OF COMPLIANCE AS THE SECRETARY OF STATE MAY  
2 REQUIRE.

3 (2) EVERY APPLICATION FOR A NO-HELMET ENDORSEMENT SHALL BE  
4 ACCOMPANIED BY THE FOLLOWING FEES, WHICH SHALL BE IN ADDITION TO  
5 ANY OTHER ORIGINAL OR RENEWAL OPERATOR LICENSE FEE, ORIGINAL OR  
6 RENEWAL CHAUFFEUR LICENSE FEE, OR ORIGINAL OR RENEWAL MOTORCYCLE  
7 ENDORSEMENT FEE:

8 ORIGINAL NO-HELMET ENDORSEMENT .....	\$25.00
9 RENEWAL OF NO-HELMET ENDORSEMENT .....	\$25.00

10 (3) A NO-HELMET ENDORSEMENT ISSUED UNDER THIS SECTION IS VALID  
11 FOR 1 YEAR. A NO-HELMET ENDORSEMENT SHALL BE RENEWED IN THE SAME  
12 MANNER PROVIDED FOR PROCURING AN ORIGINAL NO-HELMET ENDORSEMENT.

13 (4) THE MONEY RECEIVED AND COLLECTED UNDER THIS SECTION SHALL  
14 BE CREDITED TO THE GENERAL FUND.
