THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 437. (1) FOR THE 2005 TAX YEAR AND EACH TAX YEAR AFTER
- 2 THE 2005 TAX YEAR, AN INDIVIDUAL MAY DESIGNATE ON HIS OR HER ANNUAL
- 3 RETURN THAT A CONTRIBUTION OF \$2.00 OR MORE OF HIS OR HER REFUND BE
- 4 CREDITED TO THE MICHIGAN COUNCIL FOR ARTS AND CULTURAL AFFAIRS IN
- 5 THE DEPARTMENT OF HISTORY, ARTS, AND LIBRARIES. IF AN INDIVIDUAL'S
- 6 REFUND IS NOT SUFFICIENT TO MAKE A CONTRIBUTION UNDER THIS SECTION,
- 7 THE INDIVIDUAL MAY DESIGNATE A CONTRIBUTION AMOUNT AND THAT
- 8 CONTRIBUTION AMOUNT SHALL BE ADDED TO THE INDIVIDUAL'S TAX
- 9 LIABILITY FOR THE TAX YEAR.
