THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 32704A. (1) THE GOVERNOR SHALL ESTABLISH A PUBLIC COMMENT
- 2 PERIOD WITH REGARD TO A PROPOSAL SUBJECT TO 42 USC 1962D-20 TO
- 3 DIVERT OR EXPORT WATER FROM THE GREAT LAKES OR FROM A TRIBUTARY OF
- 4 THE GREAT LAKES OUTSIDE OF THE GREAT LAKES BASIN IF ANY OF THE
- 5 FOLLOWING OCCUR:
 - (A) NOTICE OF A PROPOSAL IS RECEIVED FROM ANOTHER GOVERNOR
- 7 UNDER 42 USC 1962D-20.
 - (B) THE GOVERNOR HAS RECEIVED A REQUEST FROM ANOTHER STATE TO

- 1 EXERCISE HIS OR HER AUTHORITY UNDER 42 USC 1962D-20 TO PROHIBIT THE
- 2 DIVERSION OR EXPORT.
- 3 (C) THE GOVERNOR HAS RECEIVED A PETITION FROM 25 OR MORE
- 4 RESIDENTS OF THE STATE ASKING THE GOVERNOR TO EXERCISE HIS OR HER
- 5 AUTHORITY UNDER 42 USC 1962D-20 TO PROHIBIT THE DIVERSION OR
- 6 EXPORT.
- 7 (2) IF THE GOVERNOR DETERMINES THAT A PUBLIC COMMENT PERIOD

- 20 (B) A DESCRIPTION OF THE PROPOSED DIVERSION OR EXPORT,
- 21 INCLUDING THE LOCATION AND SIZE OF THE DIVERSION OR EXPORT, AND THE
- 22 STATE TO WHICH THE WATER WILL BE DIVERTED OR EXPORTED.
- 23 (C) THE NAME AND ADDRESS WHERE MORE INFORMATION MAY BE
- 24 OBTAINED.
- 25 (3) THE PUBLIC COMMENT PERIOD UNDER SUBSECTION (2) SHALL BE
- 26 HELD OPEN FOR A PERIOD OF NOT LESS THAN 30 DAYS. UPON REQUEST FROM
- 27 1 OR MORE PERSONS, THE DEPARTMENT SHALL HOLD A PUBLIC HEARING.

- 1 (4) FOLLOWING THE PUBLIC COMMENT PERIOD AND PUBLIC HEARING, IF
- 2 HELD, THE DEPARTMENT SHALL EVALUATE THE PROPOSAL AND PROVIDE
- 3 RECOMMENDATIONS TO THE GOVERNOR. THE EVALUATION SHALL FOLLOW THE
- 4 PROCEDURE PROVIDED IN GUIDELINES ADOPTED UNDER SUBSECTION (5).

- 13 SUPPLIES.
- 14 (B) WHETHER THE APPLICANT HAS SUCCESSFULLY IMPLEMENTED ALL
- 15 APPLICABLE CONSERVATION MEASURES.
- 16 (C) WHETHER THE PROPOSAL WILL RESULT IN ANY ADVERSE IMPACTS
- 17 EITHER INDIVIDUALLY OR CUMULATIVELY TO THE QUANTITY OR QUALITY OF
- 18 WATERS AND WATER-DEPENDENT NATURAL RESOURCES OF THE GREAT LAKES
- 19 BASIN WITH CONSIDERATION OF ANY PRECEDENT-SETTING CONSEQUENCES
- 20 ASSOCIATED WITH THE PROPOSAL.
- 21 (D) WHETHER THE PROPOSAL WILL RESULT IN AN IMPROVEMENT TO THE
- 22 WATERS AND WATER-DEPENDENT NATURAL RESOURCES OF THE GREAT LAKES
- 23 BASIN AND WHETHER THE PROPOSAL DEMONSTRATES HOW MEASURES WILL BE
- 24 IMPLEMENTED TO IMPROVE THE PHYSICAL, CHEMICAL, AND BIOLOGICAL
- 25 INTEGRITY OF THE WATERS AND WATER-DEPENDENT NATURAL RESOURCES OF
- 26 THE GREAT LAKES BASIN.
- 27 (E) WHETHER THE PROPOSAL IS FOR A PUBLIC WATER SUPPLY ONLY.

- 1 (F) WHETHER THERE IS A MAXIMUM RETURN FLOW OF WATER FROM THE
- 2 PROPOSED DIVERSION.
- 3 (G) WHETHER THE WATER RETURNED IS THE EXACT WATER WITHDRAWN
- 4 AND IS IN A CONDITION THAT, USING BEST AVAILABLE TECHNOLOGY,
- 5 PROTECTS THE QUALITY OF THE WATER AND PREVENTS THE INTRODUCTION OF
- 6 AQUATIC NUISANCE SPECIES INTO THE WATER.
- 7 (H) WHETHER THE POINT OF RETURN FOR RETURNED FLOW IS IN THE
- 8 SAME WATERSHED AS THE POINT OF WITHDRAWAL USING THE SMALLEST SCALE
- 9 OF WATERSHED AS DEFINED BY THE UNITED STATES GEOLOGICAL SURVEY AT
- 10 THE POINT OF WITHDRAWAL.
- 11 (I) WHETHER THE POINT OF RETURN FOR RETURNED FLOW IS AS CLOSE
- 12 AS POSSIBLE TO THE POINT OF WITHDRAWAL, UNLESS SUCH A RETURN WOULD
- 13 FOR SOME REASON BE ECOLOGICALLY HARMFUL.
