- 3 EDUCATION OR JOB SKILLS PROGRAM FOR A MINIMUM OF 30 HOURS PER WEEK.
- 4 PARTICIPATION IN A PROGRAM UNDER THIS SUBSECTION SHALL NOT EXCEED A
- 5 PERIOD LONGER THAN 180 DAYS.
- 6 (2) A WORK FIRST PARTICIPANT WHO HAS NOT EARNED A HIGH SCHOOL
- 7 DIPLOMA OR SUCCESSFULLY COMPLETED A GENERAL EDUCATION DEVELOPMENT
- 8 (GED) TEST AND WHO ENROLLS IN A GENERAL EDUCATION DEVELOPMENT (GED)
 - PREPARATION COURSE MAY COUNT UP TO 10 HOURS PER WEEK SPENT IN

- 24 PLACED IN EMPLOYMENT WHO REMAIN EMPLOYED FOR A PERIOD OF 180 DAYS
- 25 OR MORE.
- 26 (D) THE NUMBER AND PERCENTAGE OF WORK FIRST PARTICIPANTS WHOSE
- 27 CASES ARE CLOSED DUE TO SELF-SUFFICIENCY.
