A bill to amend 1979 PA 94, entitled "The state school aid act of 1979,"

(MCL 388.1601 to 388.1772) by adding section 105d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 105D. (1) NOT LATER THAN JUNE 1, 2006, THE BOARD OF EACH
- 2 DISTRICT SHALL DEVELOP AND IMPLEMENT A POLICY FOR CONSIDERING
- 3 REQUESTS FOR APPROVAL FOR PUPILS WHO RESIDE IN THE DISTRICT TO
- 4 ENROLL AND BE COUNTED IN MEMBERSHIP IN ANOTHER DISTRICT, AS
- 5 PROVIDED UNDER SECTION 6(6). THE POLICY SHALL PROVIDE FOR AT LEAST
- 6 ALL OF THE FOLLOWING:
- 7 (A) A HEARING PROCESS THAT ALLOWS BOTH THE REQUESTING PARENT
- 8 OR LEGAL GUARDIAN AND THE SCHOOL ADMINISTRATION THE OPPORTUNITY TO

- 1 BE HEARD BEFORE THE BOARD GRANTS OR DENIES APPROVAL.
- 2 (B) A PROCESS FOR A RESIDENT PUPIL WHO ENROLLS IN ANOTHER
- 3 DISTRICT TO RETURN TO THE DISTRICT OF RESIDENCE. THIS PART OF THE
- 4 POLICY SHALL ADDRESS A PUPIL'S RETURN IN THE EVENT OF EXPULSION
- 5 FROM THE OTHER DISTRICT.
- 6 (C) IF THE DISTRICT GRANTS APPROVAL FOR A RESIDENT PUPIL TO
