## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 276. (1) FOR TAX YEARS THAT END AFTER DECEMBER 31, 2005,
- 2 AN ELIGIBLE TAXPAYER MAY CLAIM A CREDIT AGAINST THE TAX IMPOSED BY
- 3 THIS ACT EQUAL TO 100% OF THE COSTS PAID, AND NOT OTHERWISE
- 4 REIMBURSED TO THE TAXPAYER, BY THE ELIGIBLE TAXPAYER IN THE TAX
  - YEAR FOR WEATHERIZATION OF THE ELIGIBLE TAXPAYER'S HOME.
  - (2) IF THE AMOUNT OF THE CREDIT ALLOWED UNDER THIS SECTION
  - EXCEEDS THE TAX LIABILITY OF THE TAXPAYER FOR THE TAX YEAR, THAT
  - PORTION OF THE CREDIT THAT EXCEEDS THE TAX LIABILITY SHALL BE

- 1 (A) "ELIGIBLE TAXPAYER" MEANS A TAXPAYER THAT MEETS THE

- 3 (B) "WEATHERIZATION" MEANS THE MODIFICATION OF THE ELIGIBLE
- 4 TAXPAYER'S HOME AND HOME HEATING SYSTEMS TO IMPROVE HEATING
- 5 EFFICIENCY, INCLUDING, BUT NOT LIMITED TO, CAULKING AND WEATHER-
- 6 STRIPPING, INSULATION OF CEILINGS, ATTICS, WALLS, FLOORS, OR WATER
- 7 HEATERS, AND INSTALLATION OF FURNACE IGNITION SYSTEMS, CLOCK
- 8 THERMOSTATS, STORM WINDOWS, OR STORM DOORS.
