THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2264A. (1) ANY POLICY OR CERTIFICATE DELIVERED, ISSUED
- 2 FOR DELIVERY, OR RENEWED IN THIS STATE THAT PROVIDES FOR HOSPITAL
- 3 OR MEDICAL CARE COVERAGE OR REIMBURSEMENT FOR HOSPITAL OR MEDICAL
- 4 CARE FOR DEPENDENT CHILDREN WHO ARE FULL-TIME OR PART-TIME STUDENTS
- 5 SHALL CONTINUE COVERAGE FOR THAT DEPENDENT STUDENT IF THE DEPENDENT
- 6 STUDENT IS COVERED UNDER THAT POLICY OR CERTIFICATE AND TAKES A
- 7 LEAVE OF ABSENCE FROM SCHOOL DUE TO ILLNESS OR INJURY. COVERAGE
- 8 UNDER THIS SECTION SHALL CONTINUE FOR 12 MONTHS FROM THE LAST DAY
