## **HOUSE BILL No. 5983**

April 25, 2006, Introduced by Reps. Donigan, Tobocman, Hopgood, Alma Smith, Kolb, Lipsey, Byrnes, Anderson, Angerer, Cushingberry, Vagnozzi, Polidori, Gonzales, Wojno and Bieda and referred to the Committee on House Oversight, Elections, and Ethics.

A bill to amend 1976 PA 388, entitled "Michigan campaign finance act,"

(MCL 169.201 to 169.282) by adding section 57a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 57A. (1) SUBJECT TO SUBSECTION (2), A CANDIDATE,
- 2 COMMITTEE, OR PERSON ACTING ON BEHALF OF A CANDIDATE OR COMMITTEE
- 3 SHALL NOT SOLICIT OR ACCEPT A CONTRIBUTION IN A FACILITY OWNED OR
- 4 LEASED BY, OR ON BEHALF OF, THIS STATE, A PUBLIC BODY, OR A
- 5 DIVISION OR AGENCY OF THE COURT OF JUSTICE OF THIS STATE.
- 6 (2) SUBSECTION (1) DOES NOT APPLY TO A CONTRIBUTION SOLICITED
  - OR ACCEPTED IN ANY OF THE FOLLOWING:
- 8 (A) A PUBLIC FACILITY OWNED OR LEASED BY, OR ON BEHALF OF, A
- 9 PUBLIC BODY IF THAT FACILITY IS PRIMARILY USED AS A FAMILY DWELLING
- 10 AND IS NOT USED TO CONDUCT A FUND-RAISING EVENT.
