## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 21737. (1) A NURSING HOME SHALL NOT BE LICENSED UNDER
- 2 THIS PART UNLESS THE NURSING HOME IS FULLY SPRINKLERED.
- 3 (2) WITHIN 6 MONTHS AFTER THE EFFECTIVE DATE OF THIS SECTION,
- 4 A NURSING HOME LICENSED UNDER THIS PART THAT IS NOT FULLY
- 5 SPRINKLERED SHALL, IN ACCORDANCE WITH THE FIRE PREVENTION CODE,
- 6 1941 PA 207, MCL 29.1 TO 29.34, SUBMIT DETAILED PLANS AND
- 7 SPECIFICATIONS OF THE INSTALLATION OF A FIRE SUPPRESSION SYSTEM OR
- 8 THE RETROFITTING OF ITS CURRENT SYSTEM TO THE STATE FIRE MARSHAL
  - AND PROVIDE THE DEPARTMENT, UPON REQUEST, COPIES OF THE SAME. NOT

- 1 LATER THAN 1 YEAR AFTER THE EFFECTIVE DATE OF THIS SECTION, EACH OF
- 2 THOSE NURSING HOMES SHALL HAVE AN AUTOMATIC FIRE SUPPRESSION SYSTEM
- 3 INSTALLED ON EACH FLOOR THAT IS APPROVED BY THE STATE FIRE MARSHAL.
