## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 177. (1) THE INDIGENT DEFENSE COUNSEL FUND IS CREATED
- 2 WITHIN THE STATE TREASURY.
- 3 (2) THE STATE TREASURER SHALL CREDIT TO THE FUND ALL BAIL BOND
- 4 SURCHARGES AND INDIGENT DEFENSE COUNSEL FEES RECEIVED UNDER SECTION
- 5 6(4) OF CHAPTER V AND SECTION 3D OF CHAPTER XI OF THE CODE OF
- 6 CRIMINAL PROCEDURE, 1927 PA 175, MCL 765.6 AND 771.3D, AND MAY
- 7 RECEIVE MONEY OR OTHER ASSETS FROM ANY SOURCE FOR DEPOSIT INTO THE
- 8 FUND. THE STATE TREASURER SHALL DIRECT THE INVESTMENT OF THE FUND.
- 9 THE STATE TREASURER SHALL CREDIT TO THE FUND INTEREST AND EARNINGS
- 10 FROM FUND INVESTMENTS.
