HOUSE BILL No. 6284

June 29, 2006, Introduced by Reps. Meyer, Sak, Vander Veen, Clemente, Murphy, Gaffney, Shaffer, Ball, Stahl and Pastor and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending section 1481 (MCL 380.1481), as added by 2000 PA 230.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1481. (1) Not later than the beginning of the 2000-2001
- 2 school year, the Michigan virtual university shall develop,
- 3 implement, and operate the Michigan virtual high school, as
- 4 described in this section.
- 5 (2) The Michigan virtual high school shall have the following6 qoals:
 - (a) Significantly expand curricular offerings for high schools across this state through agreements with school districts or licenses from other recognized providers.
 - (b) Create a statewide instructional model using interactive

- 1 multimedia tools delivered by electronic means, including, but not
