- 1 SEC. 411U. (1) A PERSON WHO HAS BEEN CONVICTED OF ANY OF THE
- 2 FOLLOWING OFFENSES SHALL NOT ACCESS A COMMERCIAL SOCIAL NETWORKING
- 3 WEBSITE:
- 4 (A) SECTION 520B, 520C, 520D, OR 520E OF THE MICHIGAN PENAL
- 5 CODE, 1931 PA 328, MCL 750.520B, 750.520C, 750.520D, AND 750.520E,
- 6 HAVING TO DO WITH CRIMINAL SEXUAL CONDUCT.
- 7 (B) SECTION 145C OF THE MICHIGAN PENAL CODE, 1931 PA 328, MCL
- 8 750.145C, HAVING TO DO WITH CHILD SEXUALLY ABUSIVE ACTIVITY OR
- 9 MATERIALS.

- 14 SHARE THAT JOURNAL WITH OTHER USERS.
- 15 (C) PERMITS REGISTERED USERS TO SHARE HIGHLY PERSONALIZED
- 16 INFORMATION.
- 17 (D) ENABLES COMMUNICATION AMONG USERS.
