- 8 WHO IS A GRADUATE OF A NURSE EDUCATION PROGRAM THAT IS LOCATED
- 9 OUTSIDE OF THE UNITED STATES IF HE OR SHE MEETS THE REQUIREMENTS OF

- 1 (A) PROVIDES VERIFICATION THAT THE NURSE EDUCATION PROGRAM
