- 5 PRODUCT THAT A MANUFACTURER OR OTHER PERSON HAS CONDUCTED OR
- 6 SPONSORED OR IS IN THE PROCESS OF CONDUCTING OR SPONSORING:
 - (A) THE NAME OF THE PERSON THAT CONDUCTED OR IS CONDUCTING THE
- 8 CLINICAL TRIAL.
