- 2 SEC. 17906. (1) A LICENSE ISSUED BY THE DEPARTMENT UNDER
- 3 SECTION 17905 SHALL BE FOR A 3-YEAR LICENSE CYCLE. THE LICENSE IS
- 4 RENEWABLE UPON PAYMENT OF THE PRESCRIBED LICENSE RENEWAL FEE AND,
- 5 BEGINNING WITH THE THIRD YEAR AFTER THE EFFECTIVE DATE OF THE RULES
- 6 PROMULGATED UNDER SECTION 17905(2), SUBMISSION TO THE DEPARTMENT OF
- 7 PROOF OF SATISFACTORY COMPLETION OF AT LEAST 8 CLOCK HOURS OF

- 12 HER APPLICATION FOR LICENSE RENEWAL PROOF SATISFACTORY TO THE
- 13 DEPARTMENT OF BOTH OF THE FOLLOWING:
- 14 (A) THAT HE OR SHE HAS SUCCESSFULLY COMPLETED A COURSE OF
- 15 TRAINING IN FIRST AID, CARDIOPULMONARY RESUSCITATION, AND FOREIGN
- 16 BODY OBSTRUCTION OF THE AIRWAY APPROVED BY THE DEPARTMENT AND
- 17 OFFERED OR APPROVED BY THE AMERICAN RED CROSS, THE AMERICAN HEART
- 18 ASSOCIATION, OR A COMPARABLE ORGANIZATION, AS DETERMINED BY THE

- 23 ISSUED BY THE ORGANIZATION OFFERING THE TRAINING.

- 25 PARTY REIMBURSEMENT FOR SERVICES RENDERED BY AN INDIVIDUAL LICENSED
- 26 UNDER THIS PART.
