May 2, 2006, Introduced by Senators BRATER, SCOTT, CHERRY, OLSHOVE, BASHAM, THOMAS, CLARK-COLEMAN, SWITALSKI, PRUSI, WHITMER, LELAND, SCHAUER, JACOBS, BARCIA and EMERSON and referred to the Committee on Economic Development, Small Business and Regulatory Reform.

A bill to amend 1984 PA 431, entitled
"The management and budget act,"

(MCL 18.1101 to 18.1594) by adding section 268a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 268A. (1) A BID FOR A STATE CONTRACT FOR SERVICES SHALL
- 2 NOT BE CONSIDERED FOR AWARD UNLESS THE BIDDER SUBMITS AN OUTSOURCED
- 3 WORKER ACCOUNTABILITY FORM WITH THE BID THAT INCLUDES ALL OF THE
- 4 FOLLOWING INFORMATION:
 - (A) THE PERCENTAGE OF THE TOTAL BID PRICE THAT WOULD BE PAID
- 6 FOR SERVICES PERFORMED BY WORKERS OUTSIDE OF MICHIGAN BUT INSIDE
- 7 THE UNITED STATES AND THE AMOUNT THAT WOULD BE PAID FOR THOSE
- 8 SERVICES UNDER THE BID.
- 9 (B) THE PERCENTAGE OF THE TOTAL BID PRICE THAT WOULD BE PAID
- 10 FOR SERVICES PERFORMED BY WORKERS OUTSIDE OF THE UNITED STATES AND

- 1 THE AMOUNT THAT WOULD BE PAID FOR THOSE SERVICES UNDER THE BID.
- 2 (C) THE NUMBER OF UNEMPLOYED OUTSOURCED WORKERS WHO WOULD BE
- 3 HIRED TO PERFORM SERVICES IF A CONTRACT IS AWARDED ON THE BID AND
- 4 THE AMOUNT THAT WOULD BE PAID TO THOSE WORKERS UNDER THE CONTRACT.
- 5 (2) IN AWARDING A CONTRACT FOR STATE SERVICES, THE BID
- 6 EVALUATOR MAY GRANT A PREFERENCE TO A BIDDER THAT WOULD PERFORM A
- 7 HIGHER PERCENTAGE OF THE SERVICES IN MICHIGAN OR THAT WOULD UTILIZE
- 8 A LARGER NUMBER OF OUTSOURCED WORKERS. A PREFERENCE UNDER THIS
- 9 SUBSECTION SHALL BE GRANTED IN THE BEST INTERESTS OF THE STATE.
- 10 (3) A CONTRACT AWARDEE SHALL PROMPTLY UPDATE THE OUTSOURCED
- 11 WORKER ACCOUNTABILITY FORM IF THERE IS A CHANGE IN THE INFORMATION
- 12 SUBMITTED. IF THE CONTRACT EXTENDS FOR MORE THAN A YEAR, THE
- 13 CONTRACTOR SHALL SUBMIT AN UPDATED OUTSOURCED WORKER ACCOUNTABILITY
- 14 FORM AT 12-MONTH INTERVALS.
- 15 (4) A CONTRACTOR WHO SUBMITS FALSE INFORMATION INDICATING A
- 16 HIGHER PERCENTAGE OR DOLLAR VALUE OF SERVICES PERFORMED IN MICHIGAN
- 17 OR A HIGHER NUMBER OF OUTSOURCED WORKERS THAN ACTUALLY PAID OR
- 18 EMPLOYED UNDER THE CONTRACT MAY BE DEBARRED FROM BIDDING FOR OR
- 19 AWARD OF STATE CONTRACTS IN ADDITION TO INCURRING ANY SANCTIONS OR
- 20 LIOUIDATED DAMAGES PROVIDED IN THE CONTRACT.
- 21 (5) AS USED IN THIS SECTION, "OUTSOURCED WORKER" MEANS
- 22 ADVERSELY AFFECTED WORKER AS THAT TERM IS DEFINED IN 20 CFR 617.3.
