SENATE BILL No. 1436

September 14, 2006, Introduced by Senator HAMMERSTROM and referred to the Committee on Government Operations.

A bill to amend 1954 PA 116, entitled "Michigan election law,"

by amending sections 744 and 931 (MCL 168.744 and 168.931), section 744 as amended by 1995 PA 261 and section 931 as amended by 1996 PA 583, and by adding section 736b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 736B. (1) EXCEPT AS PROVIDED IN SECTION 736A, ON THE DAY
 - OF AN ELECTION, ONLY THE FOLLOWING PERSONS SHALL BE ALLOWED TO
- 3 ENTER AN ELECTION PRECINCT POLLING PLACE:
 - (A) A QUALIFIED ELECTOR VOTING AT THE ELECTION PRECINCT
- 5 POLLING PLACE.
 - (B) AN ELECTION OFFICIAL.
 - (C) A CHALLENGER WHO IS APPROVED UNDER SECTION 731.

- 1 (2) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A
- 2 MISDEMEANOR.
- 3 Sec. 744. (1) An election inspector or any other person in
- 4 the A polling room, or in a compartment connected to the A
- 5 polling room, or within 100 feet from any entrance to the building
- 6 in which the polling place is located IN A CAMPAIGN-FREE ZONE
- 7 shall not persuade or endeavor to persuade a person to vote for or
- 8 against any particular candidate or party ticket —, or for or
- 9 against any ballot question that is being voted on at the election.
- 10 A person shall not place or distribute stickers, other than
- 11 stickers provided by the election officials pursuant to law, in
- 12 the A polling room, or in a compartment connected to the A
- 13 polling room, or -within 100 feet from any entrance to the building
- 14 in which the polling place is located IN A CAMPAIGN-FREE ZONE.
- 15 (2) A person shall not solicit donations, gifts,
- 16 contributions, purchase of tickets, or similar demands, -or
- 17 request or obtain signatures on petitions, DISTRIBUTE ANYTHING OF
- 18 VALUE, OR DISTRACT A VOTER in -the- A polling room, -or- in a
- 19 compartment connected to the A polling room, or within 100 feet
- 20 from any entrance to the building in which the polling place is
- 21 located IN A CAMPAIGN-FREE ZONE.
- 22 (3) On election day, a person shall not post, display, or
- 23 distribute in a polling place, in any hallway used by voters to
- 24 enter or exit a polling place, or within 100 feet of an entrance
- 25 to a building in which a polling place is located IN A CAMPAIGN-
- 26 FREE ZONE any material that directly or indirectly makes reference
- 27 to an election, a candidate, or a ballot question. This subsection

- 1 does not apply to official material that is required by law to be
- 2 posted, displayed, or distributed in a polling place on election
- 3 day.
- 4 (4) A person who violates this section is guilty of a
- 5 misdemeanor.
- 6 (5) AN ORGANIZATION SHALL NOT REQUIRE, SOLICIT, INDUCE, OR
- 7 INTIMIDATE A PERSON TO VIOLATE SUBSECTION (1), (2), OR (3). AN
- 8 ORGANIZATION THAT VIOLATES THIS SUBSECTION IS SUBJECT TO A CIVIL
- 9 FINE OF NOT MORE THAN \$1,000.00 FOR EACH VIOLATION.
- 10 (6) AS USED IN THIS SECTION, "CAMPAIGN-FREE ZONE" MEANS THE
- 11 AREA WITHIN 100 FEET OF AN ENTRANCE TO A BUILDING IN WHICH A
- 12 POLLING PLACE IS LOCATED.
- Sec. 931. (1) A person who violates 1 or more of the following
- 14 subdivisions is guilty of a misdemeanor:
- 15 (a) A person shall not, either directly or indirectly, give,
- 16 lend, or promise valuable consideration $\overline{}$ to or for any person $\overline{}$
- 17 as an inducement to influence the manner of voting by a person
- 18 relative to a candidate or ballot question or as a reward for
- 19 refraining from voting.
- 20 (b) A person shall not, either before, on, or after an
- 21 election, for the person's own benefit or on behalf of any other
- 22 person, receive, agree, or contract for valuable consideration for
- 23 1 or more of the following:
- (i) Voting or agreeing to vote, or inducing or attempting to
- 25 induce another to vote, at an election.
- 26 (ii) Refraining or agreeing to refrain, or inducing or
- 27 attempting to induce another to refrain, from voting at an

- 1 election.
- 2 (iii) Doing anything prohibited by this act.
- 3 (iv) Both distributing absent voter ballot applications to
- 4 voters and receiving signed applications from voters for delivery
- 5 to the appropriate clerk or assistant of the clerk. This
- 6 subparagraph does not apply to an authorized election official.
- 7 (c) A person shall not solicit any valuable consideration from
- 8 a candidate for nomination for, or election to, an office described
- 9 in this act. This subdivision does not apply to requests for
- 10 contributions of money by or to an authorized representative of the
- 11 political party committee of the organization to which the
- 12 candidate belongs. This subdivision does not apply to a regular
- 13 business transaction between a candidate and any other person that
- 14 is not intended for, or connected with, the securing of votes or
- 15 the influencing of voters in connection with the nomination or
- 16 election.
- 17 (d) A person shall not, either directly or indirectly,
- 18 discharge or threaten to discharge an employee of the person for
- 19 the purpose of influencing the employee's vote at an election.
- (e) A priest, pastor, curate, or other officer of a religious
- 21 society shall not, for the purpose of influencing a voter at an
- 22 election, impose or threaten to impose upon the voter a penalty of
- 23 excommunication, dismissal, or expulsion or command or advise
- 24 the voter under pain of religious disapproval.
- 25 (f) A person shall not hire a motor vehicle or other
- 26 conveyance or cause the same to be done, for conveying voters,
- 27 other than voters physically unable to walk, to an election.

- 1 (g) In a city, township, village, or school district that has
- 2 a board of election commissioners authorized to appoint **ELECTION**
- 3 inspectors, of election, an ELECTION inspector, of election, a
- 4 clerk, or other election official who accepts an appointment as an
- 5 **ELECTION** inspector of election shall not fail to report at the
- 6 polling place designated on election morning at the time specified
- 7 by the board of election commissioners, unless excused as provided
- 8 in this subdivision. A person who violates this subdivision is
- 9 guilty of a misdemeanor punishable by a fine of not more than
- 10 \$10.00 or imprisonment for not more than 10 days, or both. An
- 11 **ELECTION** inspector, of election, clerk, or other election
- 12 official who accepts an appointment as an **ELECTION** inspector —of
- 13 election is excused for failing to report at the polling place on
- 14 election day and is not subject to a fine or imprisonment under
- 15 this subdivision if 1 or more of the following requirements are
- **16** met:
- 17 (i) The **ELECTION** inspector, $\frac{\text{of election}}{\text{of other}}$ clerk, or other
- 18 election official notifies the board of election commissioners or
- 19 other officers in charge of elections of his or her inability to
- 20 serve at the time and place specified, 3 days or more before the
- 21 election.
- 22 (ii) The **ELECTION** inspector, -of election, clerk, or other
- 23 election official is excused from duty by the board of election
- 24 commissioners or other officers in charge of elections for cause
- 25 shown.
- 26 (h) A person shall not willfully fail to perform a duty
- 27 imposed upon that person by this act or disobey a lawful

- 1 instruction or order of the secretary of state as chief state
- 2 election officer or of a board of county election commissioners,
- 3 board of city election commissioners, or board of **ELECTION**
- 4 inspectors. of election.
- 5 (i) A delegate or member of a convention shall not solicit a
- 6 candidate for nomination before the convention for money, reward,
- 7 position, place, preferment, or other valuable consideration in
- 8 return for support by the delegate or member in the convention. A
- 9 candidate or other person shall not promise or give to a delegate
- 10 money, reward, position, place, preferment, or other valuable
- 11 consideration in return for support by or vote of the delegate in
- 12 the convention.
- 13 (j) A person elected to the office of delegate to a convention
- 14 shall not accept or receive any money or other valuable
- 15 consideration for his or her vote as a delegate.
- 16 (k) A person shall not, while the polls are open on an
- 17 election day, solicit votes in a polling place or within 100 feet
- 18 from an entrance to the building in which a polling place is
- 19 located IN A CAMPAIGN-FREE ZONE.
- 20 (1) A person shall not keep a room or building for the purpose,
- 21 in whole or in part, of recording or registering bets or wagers —,
- 22 or of selling pools upon the result of a political nomination,
- 23 appointment, or election. A person shall not wager property, money,
- 24 or thing of value, or be the custodian of money, property, or thing
- 25 of value —, staked, wagered, or pledged, upon the result of a
- 26 political nomination, appointment, or election.
- 27 (m) A person shall not participate in a meeting or a portion

- 1 of a meeting of more than 2 persons, other than the person's
- 2 immediate family, at which an absent voter ballot is voted.
- 3 (n) A person, other than an authorized election official,
- 4 shall not, either directly or indirectly, give, lend, or promise
- 5 any valuable consideration to or for a person to induce that person
- 6 to both distribute absent voter ballot applications to voters and
- 7 receive signed absent voter ballot applications from voters for
- 8 delivery to the appropriate clerk.
- 9 (O) A PERSON SHALL NOT IMPERSONATE IN ANY WAY AN ELECTION
- 10 OFFICIAL.
- 11 (2) A person who violates a provision of this act for which a
- 12 penalty is not otherwise specifically provided in this act is
- 13 guilty of a misdemeanor.
- 14 (3) A person or a person's agent who knowingly makes,
- 15 publishes, disseminates, circulates, or places before the public,
- 16 or knowingly causes directly or indirectly to be made, published,
- 17 disseminated, circulated, or placed before the public, in this
- 18 state, either orally or in writing, an assertion, representation,
- 19 or statement of fact concerning a candidate for public office at an
- 20 election in this state, that is false, deceptive, scurrilous, or
- 21 malicious, without the true name of the author being subscribed to
- 22 the assertion, representation, or statement if written, or
- 23 announced if unwritten, is guilty of a misdemeanor.
- 24 (4) As used in this section: -, "valuable
- 25 (A) "CAMPAIGN-FREE ZONE" MEANS THE AREA WITHIN 100 FEET OF AN
- 26 ENTRANCE TO A BUILDING IN WHICH A POLLING PLACE IS LOCATED.
- 27 (B) "VALUABLE consideration" includes, but is not limited to,

- 1 money, property, a gift, a prize or chance for a prize, a fee, a
- 2 loan, an office, a position, an appointment, or employment.
