SENATE BILL No. 1443

September 14, 2006, Introduced by Senator McMANUS and referred to the Committee on Government Operations.

A bill to amend 1976 PA 388, entitled "Michigan campaign finance act," by amending section 47 (MCL 169.247), as amended by 2001 PA 250.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 47. (1) Except as otherwise provided in this subsection 2 and subject to subsections $\frac{(3)}{(3)}$ and $\frac{(4)}{(3)}$ AND $\frac{(5)}{(5)}$, a billboard, 3 placard, poster, pamphlet, or other printed matter having reference to an election, a candidate, or a ballot question, shall bear upon 5 it the name and address of the person paying for the matter. Except as otherwise provided in this subsection and subject to subsections (3) and (4) AND (5), if the printed matter relating to a candidate

- 1 is an independent expenditure that is not authorized in writing by
- 2 the candidate committee of that candidate, the printed matter shall
- 3 contain the following disclaimer: "Not authorized by any candidate
- 4 committee". An individual other than a candidate is not subject to
- 5 this subsection if the individual is acting independently and not
- 6 acting as an agent for a candidate or any committee.
- 7 (2) A radio or television paid advertisement having reference
- 8 to an election, a candidate, or a ballot question shall identify
- 9 the sponsoring person as required by the federal communications

- 11 advertisement, and -shall be in compliance COMPLY with subsection
- 12 (3) and with the following:
- 13 (a) If the radio or television paid advertisement relates to a

- 15 shall contain the following disclaimer: "Not authorized by any

- 17 (b) If the radio or television paid advertisement relates to a
- 18 candidate and is not an independent expenditure but is paid for by
- 19 a person other than the candidate to which it is related WHOM IT
- 20 RELATES, the advertisement shall contain the following disclaimer:

- 23 (3) A COMMUNICATION THAT RELATES TO AN ELECTION, CANDIDATE, OR

10	(4) $-(3)$ The size and placement of an identification or
11	disclaimer required by this section shall be determined by rules
12	promulgated by the secretary of state. The rules may exempt printed
13	matter and certain other items, such as campaign buttons or
14	balloons, the size of which makes it unreasonable to add an
15	identification or disclaimer, from the identification or disclaimer
16	required by this section.
17	(5) $-(4)$ Except for a candidate committee's printed matter or
18	radio or television paid advertisements, each identification or
19	disclaimer required by -this section SUBSECTION (1) OR (2) shall
20	also indicate that the printed matter or radio or television paid
21	advertisement is paid for "with regulated funds". Printed matter or
22	a radio or television paid advertisement that is not subject to
23	this act shall not bear the statement required by this subsection.
24	(6) $-(5)$ — A person who knowingly violates this section is
25	guilty of a misdemeanor punishable by a fine of not more than
26	\$1,000.00, or imprisonment for not more than 93 days, or both.
27	(7) AS USED IN THIS SECTION, "MEDIA" MEANS ANY MEANS OF
