

**SUBSTITUTE FOR
HOUSE BILL NO. 4175**

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
by amending section 312e (MCL 257.312e), as amended by 2006 PA 298.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 312e. (1) Except as otherwise provided in this section, a
2 person, before operating a commercial motor vehicle, shall obtain
3 the required vehicle group designation as follows:

4 (a) A person, before operating a combination of vehicles with
5 a gross combination weight rating of 26,001 pounds or more
6 including a towed vehicle with a gross vehicle weight rating of
7 more than 10,000 pounds, shall procure a group A vehicle
8 designation on his or her operator's or chauffeur's license. Unless
9 an indorsement or the removal of restrictions is required, a person
10 licensed to operate a group A vehicle may operate a group B or C

1 vehicle without taking another test.

2 (b) A person, before operating a vehicle having a gross
3 vehicle weight rating of 26,001 pounds or more, shall procure a
4 group B vehicle designation on his or her operator's or chauffeur's
5 license. Unless an indorsement or the removal of restrictions is
6 required, a person licensed to operate a group B vehicle may
7 operate a group C vehicle without taking another test.

8 (c) A person, before operating a single vehicle having a gross
9 vehicle weight rating under 26,001 pounds or a vehicle having a
10 gross vehicle weight rating under 26,001 pounds towing a trailer or
11 other vehicle and carrying hazardous materials on which a placard
12 is required under 49 CFR parts 100 to 199, or designed to transport
13 16 or more passengers including the driver, shall procure a group C
14 vehicle designation and a hazardous material or passenger vehicle
15 indorsement on his or her operator's or chauffeur's license.

16 (2) An applicant for a vehicle group designation shall take
17 knowledge and driving skills tests that comply with minimum federal
18 standards prescribed in 49 CFR part 383 as required under this act.

19 (3) The license shall be issued, suspended, revoked, canceled,
20 or renewed in accordance with this act.

21 (4) Except as provided in this subsection, all of the
22 following apply:

23 (a) If a person operates a group B passenger vehicle while
24 taking his or her driving skills test for a P indorsement, he or
25 she is restricted to operating only group B or C passenger vehicles
26 under that P indorsement. If a person operates a group B school bus
27 while taking his or her driving skills test for an S indorsement,

1 he or she is restricted to operating only group B or C school buses
2 under that S indorsement.

3 (b) If a person operates a group C passenger vehicle while
4 taking his or her driving skills test for a P indorsement, he or
5 she is restricted to operating only group C passenger vehicles
6 under that P indorsement. If a person operates a group C school bus
7 while taking his or her driving skills test for an S indorsement,
8 he or she is restricted to operating only group C school buses
9 under that S indorsement.

10 (c) A person who fails the air brake portion of the written or
11 driving skills test provided under section 312f or who takes the
12 driving skills test provided under that section in a commercial
13 motor vehicle that is not equipped with air brakes shall not
14 operate a commercial motor vehicle equipped with air brakes.

15 (5) A person, before operating a commercial motor vehicle,
16 shall obtain required vehicle indorsements as follows:

17 (a) A person, before operating a commercial motor vehicle
18 pulling double trailers, shall procure the appropriate vehicle
19 group designation and a T vehicle indorsement under this act.

20 (b) A person, before operating a commercial motor vehicle that
21 is a tank vehicle, shall procure the appropriate vehicle group
22 designation and an N vehicle indorsement under this act.

23 (c) A person, before operating a commercial motor vehicle
24 carrying hazardous materials on which a placard is required under
25 49 CFR parts 100 to 199, shall procure the appropriate vehicle
26 group designation and an H vehicle indorsement under this act.

27 (d) A person, before operating a commercial motor vehicle that

1 is a tank vehicle carrying hazardous material, shall procure the
2 appropriate vehicle group designation and both an N and H vehicle
3 indorsement, which shall be designated by the code letter X on the
4 person's operator's or chauffeur's license.

5 (e) A person, before operating a vehicle that is designed to
6 transport 16 or more passengers including the driver but is not a
7 school bus shall procure the appropriate vehicle group designation
8 and a P vehicle indorsement under this act. An applicant for a P
9 vehicle indorsement shall take the driving skills test in a vehicle
10 designed to transport 16 or more passengers including the driver.

11 (f) A person who does not currently possess a P indorsement,
12 before operating a school bus designed to transport 16 or more
13 passengers, including the driver, shall procure the appropriate
14 vehicle group designation, pass the knowledge tests for the P and S
15 indorsements, and procure the P and S vehicle indorsements under
16 this act. An applicant for an S vehicle indorsement shall take a
17 driving skills test in a school bus designed to transport 16 or
18 more passengers, including the driver, that represents the same
19 type of vehicle that the applicant intends to operate as a school
20 bus.

21 (g) A person who currently possesses a P indorsement, before
22 operating a school bus designed to transport 16 or more passengers,
23 including the driver, shall procure the appropriate vehicle group
24 designation, pass the knowledge test for an S indorsement, and
25 procure an S vehicle indorsement under this act. An applicant for
26 an S vehicle indorsement shall take a driving skills test in a
27 school bus designed to transport 16 or more passengers, including

1 the driver, that represents the same type of vehicle that the
2 applicant intends to operate as a school bus.

3 ~~—— (6) Until September 30, 2005, the secretary of state may waive~~
4 ~~the driving skills test for an applicant for an S indorsement if~~
5 ~~the applicant certifies, and the secretary of state verifies, that~~
6 ~~during the 2 year period immediately prior to applying for the~~
7 ~~school bus indorsement the applicant met all of the following~~
8 ~~conditions.~~

9 ~~—— (a) The applicant holds a valid driver license with a vehicle~~
10 ~~group designation and a P indorsement.~~

11 ~~—— (b) The applicant has not had an operator's, chauffeur's, or~~
12 ~~commercial motor vehicle driver license suspended, revoked, denied,~~
13 ~~or canceled.~~

14 ~~—— (c) The applicant has not been disqualified by the United~~
15 ~~States secretary of transportation from operating a commercial~~
16 ~~motor vehicle.~~

17 ~~—— (d) The applicant has not been convicted of any disqualifying~~
18 ~~offense listed in 49 CFR 383.51(b) while operating a commercial~~
19 ~~motor vehicle.~~

20 ~~—— (e) The applicant has not been convicted of any disqualifying~~
21 ~~offense listed in 49 CFR 383.51(b) while operating a noncommercial~~
22 ~~motor vehicle that would be a disqualifying offense under 49 CFR~~
23 ~~383.51(b) if the applicant had committed the offense while~~
24 ~~operating a commercial motor vehicle.~~

25 ~~—— (f) The applicant has not had more than 1 conviction for a~~
26 ~~serious traffic violation as defined in 49 CFR 383.51 while~~
27 ~~operating any type of motor vehicle.~~

~~1 (g) Except for parking violations, the applicant has not had~~
~~2 any conviction for a violation of any state or local motor vehicle~~
~~3 traffic control law involving a vehicle accident and has not been~~
~~4 found at fault in a vehicle accident.~~

~~5 (h) The applicant has been regularly employed as a school bus~~
~~6 driver for the past 2 years and has, for those 2 years, operated a~~
~~7 school bus representing the type of school bus that the applicant~~
~~8 intends to operate, and the applicant provides satisfactory~~
~~9 evidence of that employment to the secretary of state.~~

10 (6) THE SECRETARY OF STATE MAY WAIVE THE DRIVING SKILLS TEST
11 UNDER THIS SECTION FOR AN APPLICANT WHO PAYS THE APPLICABLE LICENSE
12 FEES FOR THE VEHICLE GROUP DESIGNATION OR INDORSEMENT IF THE
13 APPLICATION IS MADE WITHIN 1 YEAR OF THE APPLICANT'S HONORABLE
14 DISCHARGE FROM THE ARMED FORCES OF THE UNITED STATES AND THE
15 APPLICANT DOES BOTH OF THE FOLLOWING:

16 (A) CERTIFIES THAT DURING THE 2 YEARS IMMEDIATELY PRECEDING
17 DISCHARGE HE OR SHE MET THE CONDITIONS FOR WAIVER OF THE DRIVING
18 SKILLS TEST IN 49 CFR 383.77(A) AND WAS REGULARLY EMPLOYED IN A
19 MILITARY OCCUPATIONAL SPECIALTY THAT REQUIRED OPERATION OF A
20 COMMERCIAL MOTOR VEHICLE.

21 (B) PRESENTS MILITARY DOCUMENTATION VERIFYING THAT, FOR AT
22 LEAST THE 2 YEARS IMMEDIATELY PRECEDING DISCHARGE, HE OR SHE
23 OPERATED A VEHICLE REPRESENTATIVE OF THE COMMERCIAL MOTOR VEHICLE
24 FOR WHICH THE APPLICANT SEEKS A VEHICLE GROUP DESIGNATION OR
25 INDORSEMENT.

26 (7) ~~An~~ EXCEPT AS PROVIDED IN SUBSECTION (6), AN applicant for
27 an indorsement shall take the knowledge and driving skills tests

1 described and required under 49 CFR part 383.

2 (8) The holder of an unexpired operator's or chauffeur's
3 license may be issued a vehicle group designation and indorsement
4 valid for the remainder of the license upon meeting the
5 qualifications of section 312f and payment of the original vehicle
6 group designation fee of \$25.00 and an indorsement fee of \$5.00 per
7 indorsement, and a corrected license fee of \$18.00. A person
8 required to procure an F vehicle indorsement under subsection (10)
9 shall pay an indorsement fee of \$5.00.

10 (9) Except as otherwise provided in subsections (10) and (11),
11 this section does not apply to a driver or operator of a vehicle
12 under all of the following conditions:

13 (a) The vehicle is controlled and operated by a farmer or an
14 employee or family member of the farmer.

15 (b) The vehicle is used to transport agricultural products,
16 farm machinery, farm supplies, or a combination of these items, to
17 or from a farm.

18 (c) The vehicle is not used in the operation of a common or
19 contract motor carrier.

20 (d) The vehicle is operated within 150 miles of the farm.

21 (10) A person, before driving or operating a combination of
22 vehicles having a gross vehicle weight rating of 26,001 pounds or
23 more on the power unit that is used as described in subsection
24 (9)(a) to (d), shall obtain an F vehicle indorsement. The F vehicle
25 indorsement shall be issued upon successful completion of a
26 knowledge test only.

27 (11) A person, before driving or operating a single vehicle

1 truck having a gross vehicle weight rating of 26,001 pounds or more
2 or a combination of vehicles having a gross vehicle weight rating
3 of 26,001 pounds or more on the power unit that is used as
4 described in subsection (9)(a) to (d) for carrying hazardous
5 materials on which a placard is required under 49 CFR parts 100 to
6 199, shall successfully complete both a knowledge test and a
7 driving skills test. Upon successful completion of the knowledge
8 test and driving skills test, the person shall be issued the
9 appropriate vehicle group designation and any vehicle indorsement
10 necessary under this act.

11 (12) This section does not apply to a police officer operating
12 an authorized emergency vehicle or to a firefighter operating an
13 authorized emergency vehicle who has met the driver training
14 standards published under the ~~fire-fighters~~**FIREFIGHTERS** training
15 council act, ~~of 1966,~~ 1966 PA 291, MCL 29.361 to 29.377.

16 (13) This section does not apply to a person operating a
17 vehicle used exclusively to transport personal possessions or
18 family members for nonbusiness purposes.

19 (14) The money collected under subsection (8) for a vehicle
20 group designation or indorsement shall be deposited in the state
21 treasury to the credit of the general fund. The secretary of state
22 shall refund out of the fees collected to each county or
23 municipality acting as an examining officer or examining bureau
24 \$3.00 for each applicant examined for a first designation or
25 indorsement to an operator's or chauffeur's license and \$1.50 for
26 each renewal designation or indorsement to an operator's or
27 chauffeur's license, whose application is not denied, on the

1 condition that the money refunded shall be paid to the county or
2 local treasurer and is appropriated to the county, municipality, or
3 officer or bureau receiving that money for the purpose of carrying
4 out this act.

5 (15) Notwithstanding any other provision of this section, a
6 person operating a vehicle described in subsections (9) and (10) is
7 subject to the provisions of sections 303 and 319b.

8 (16) This state shall comply with the requirements of the
9 American association of motor vehicle administrators' AAMVAnet,
10 incorporated's "Commercial Driver License Information System
11 (CDLIS) State Procedures Manual" that the secretary of state
12 determines are required for implementing and enforcing federal law.
