SUBSTITUTE FOR HOUSE BILL NO. 4456

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 394b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 394B. (1) A PERSON SHALL NOT DO 1 OR BOTH OF THE
- 2 FOLLOWING:
- 3 (A) INTENTIONALLY PLACE AN ITEM IN OR ACROSS A ROADWAY IF THE
- 4 PERSON KNOWS OR SHOULD KNOW THAT THE ITEM IS LIKELY TO COME INTO
- 5 CONTACT WITH A MOVING VEHICLE OR ANOTHER PERSON RIDING IN OR UPON A
- 6 MOVING VEHICLE.
- 7 (B) INTENTIONALLY PLACE A DANGEROUS ITEM IN OR ACROSS A
- 8 ROADWAY.
- 9 (2) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A CRIME AS
- 10 FOLLOWS:

- (A) EXCEPT AS PROVIDED IN SUBDIVISIONS (B), (C), (D), AND (E), 1
- 2 THE PERSON IS GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT
- FOR NOT MORE THAN 93 DAYS OR A FINE OF NOT MORE THAN \$100.00, OR 3
- 4 BOTH.
- 5 (B) IF THE VIOLATION CAUSES PROPERTY DAMAGE, THE PERSON IS
- GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE
- THAN 1 YEAR OR A FINE OF NOT MORE THAN \$500.00, OR BOTH. 7
- (C) IF THE VIOLATION CAUSES INJURY TO ANY PERSON, OTHER THAN 8
- 9 SERIOUS IMPAIRMENT OR DEATH, THE PERSON IS GUILTY OF A FELONY
- 10 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR A FINE OF
- NOT MORE THAN \$2,000.00, OR BOTH. 11
- 12 (D) IF THE VIOLATION CAUSES SERIOUS IMPAIRMENT TO ANY PERSON,
- THE PERSON IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT 13
- MORE THAN 10 YEARS OR A FINE OF NOT MORE THAN \$5,000.00, OR BOTH. 14
- 15 (E) IF THE VIOLATION CAUSES DEATH TO ANY PERSON, THE PERSON IS
- GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 15 16
- 17 YEARS OR A FINE OF NOT MORE THAN \$10,000.00, OR BOTH.
- (3) A CRIMINAL PENALTY PROVIDED FOR UNDER THIS SECTION MAY BE 18
- 19 IMPOSED IN ADDITION TO ANY PENALTY THAT MAY BE IMPOSED FOR ANY
- 20 OTHER CRIMINAL OFFENSE ARISING FROM THE SAME CONDUCT OR FOR ANY
- CONTEMPT OF COURT ARISING FROM THE SAME CONDUCT. 21
- (4) AS USED IN THIS SECTION, "SERIOUS IMPAIRMENT" MEANS 22
- SERIOUS IMPAIRMENT OF A BODY FUNCTION AS THAT TERM IS DEFINED IN 23
- SECTION 58C OF THE MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.58C. 24
