HOUSE BILL NO. 6341

A bill to amend 1931 PA 328, entitled
"The Michigan penal code,"
by amending section 147b (MCL 750.147b), as added by 1988 PA 371,
and by adding section 377d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 147b. ~~(1) A person is guilty of ethnic intimidation if~~
2 ~~that person maliciously, and with specific intent to intimidate or~~
3 ~~harass another person because of that person's race, color,~~
4 ~~religion, gender, or national origin, does any of the following:~~
5 ~~— (a) Causes physical contact with another person.~~
6 ~~— (b) Damages, destroys, or defaces any real or personal~~
7 ~~property of another person.~~
8 ~~— (c) Threatens, by word or act, to do an act described in~~
9 ~~subdivision (a) or (b), if there is reasonable cause to believe~~

5 (1) A PERSON IS GUILTY OF A BIAS-MOTIVATED CRIME IF THE PERSON
6 SELECTS THE TARGET OF A PREDICATE CRIME BASED IN WHOLE OR IN PART
7 ON 1 OR MORE OF THE FOLLOWING CHARACTERISTICS, REGARDLESS OF
8 WHETHER OR NOT THE PERPETRATOR'S BELIEF OR PERCEPTION OF THE
9 CHARACTERISTIC IS CORRECT:

10 (A) DISABILITY.

11 (B) GENDER, GENDER IDENTITY, OR EXPRESSION OF GENDER.

12 (C) NATIONAL ORIGIN OR ANCESTRY.

13 (D) RACE, COLOR, OR ETHNICITY.

14 (E) RELIGION.

15 (F) SEXUAL ORIENTATION.

16 [(G) VETERANS.

17 (H)] ASSOCIATION WITH A PERSON OR GROUP WITH 1 OR MORE OF THE
18 CHARACTERISTICS IN SUBDIVISIONS (A) TO [(G)].

19 (2) A PREDICATE CRIME AGAINST PRIVATE PROPERTY IS BIAS-
20 MOTIVATED IF THE PERPETRATOR TARGETS THE PROPERTY BECAUSE OF A
21 LISTED CHARACTERISTIC OF ANY INDIVIDUAL ASSOCIATED WITH THE
22 PROPERTY.

23 (3) A PREDICATE CRIME AGAINST PUBLIC PROPERTY IS BIAS-
24 MOTIVATED IF THE PERPETRATOR DEMONSTRATES THE SPECIFIC INTENT TO
25 INTIMIDATE OR HARASS 1 OR MORE INDIVIDUALS BECAUSE OF A LISTED
26 CHARACTERISTIC.

27 (4) A BIAS-MOTIVATED CRIME IS A FELONY PUNISHABLE AS FOLLOWS:

(A) IF THE PREDICATE CRIME IS A MISDEMEANOR, BY IMPRISONMENT

1 FOR NOT MORE THAN 2 YEARS OR A FINE OF NOT MORE THAN \$5,000.00, OR
2 BOTH.

3 (B) IF THE PREDICATE CRIME IS A FELONY, BY IMPRISONMENT WITHIN
4 THE STATUTORY RANGE ESTABLISHED FOR THE PREDICATE CRIME EXCEPT THAT
5 THE MINIMUM AND MAXIMUM RECOMMENDED SENTENCING RANGE UNDER THE
6 SENTENCING GUIDELINES FOR THAT CRIME SHALL BE INCREASED BY 50%.

7 (5) A PERSON SHALL NOT BE CONVICTED OF BOTH THE LESSER
8 INCLUDED PREDICATE CRIME AND A BIAS-MOTIVATED CRIME CHARGED UNDER
9 THIS SECTION. THIS SECTION DOES NOT PROHIBIT A PERSON FROM BEING
10 CHARGED WITH, CONVICTED OF, OR SENTENCED FOR ANY OTHER VIOLATION OF
11 LAW ARISING OUT OF THE SAME CRIMINAL TRANSACTION.

12 (6) ~~(3)~~—Regardless of the existence or outcome of any criminal
13 prosecution, a person who suffers injury to his or her person or
14 damage to his or her property as a result of ~~ethnic intimidation~~ **A**
15 **BIAS-MOTIVATED CRIME** may bring a civil cause of action against the
16 person who commits the offense to secure an injunction, actual
17 damages, including damages for emotional distress, or other
18 appropriate relief. A plaintiff who prevails in a civil action
19 brought pursuant to this section may recover both of the following:

20 (a) Damages in the amount of 3 times the actual damages
21 described in this subsection or \$2,000.00, whichever is greater.

22 (b) Reasonable attorney fees and costs.

23 (7) AS USED IN THIS SECTION:

24 (A) "DISABILITY" MEANS A DETERMINABLE PHYSICAL OR MENTAL
25 CHARACTERISTIC OF AN INDIVIDUAL THAT MAY RESULT FROM DISEASE,
26 INJURY, CONGENITAL CONDITION, OR FUNCTIONAL DISORDER THAT
27 SUBSTANTIALLY LIMITS 1 OR MORE OF THE INDIVIDUAL'S MAJOR LIFE

1 ACTIVITIES.

2 (B) "GENDER, GENDER IDENTITY, OR EXPRESSION OF GENDER" MEANS A
3 PERSON'S ACTUAL OR PERCEIVED GENDER OR GENDER-RELATED APPEARANCE,
4 SELF-IMAGE, BEHAVIOR, OR EXPRESSION, WHETHER OR NOT TRADITIONALLY
5 ASSOCIATED WITH THE PERSON'S ASSIGNED SEX AT BIRTH.

6 (C) "PREDICATE CRIME" MEANS A VIOLATION OF ANY OF THE
7 FOLLOWING, BUT NOT IF PROOF OF A CHARACTERISTIC IDENTIFIED IN
8 SUBSECTION (1) (A) TO (F) IS AN ELEMENT OF THE VIOLATION:

9 (i) CHAPTER X.

10 (ii) CHAPTER XI.

11 (iii) CHAPTER XXXIII.

12 (iv) CHAPTER XLV.

13 (v) CHAPTER LVI.

14 (vi) CHAPTER LXIV.

15 (vii) CHAPTER LXXVI.

22 ELEMENT OF THE OFFENSE THE SPECIFIC INTENT TO INTIMIDATE OR HARASS
23 ANOTHER PERSON OR PERSONS.

24 (D) "SEXUAL ORIENTATION" MEANS AN ORIENTATION FOR
25 HETEROSEXUALITY, HOMOSEXUALITY, OR BISEXUALITY OR A HISTORY OF OR
26 IDENTIFICATION WITH THAT ORIENTATION.

27 SEC. 377D. FOR PURPOSES OF SECTIONS 377A TO 377C, 380, 383,

1 AND 387, A PERSON WHO, WITH INTENT TO INTIMIDATE, DOES ANY OF THE
2 FOLLOWING TO PROPERTY WITHOUT THE EXPRESS PERMISSION OF THE
3 PROPERTY OWNER IS CONSIDERED TO HAVE INJURED OR ALTERED THAT
4 PROPERTY, WHETHER OR NOT ANY PHYSICAL DAMAGE IS CAUSED:

5 (A) HANGS, AFFIXES, OR OTHERWISE PLACES A NOOSE ON THE
6 PROPERTY.

7 (B) BURNS, OR PLACES WITH INTENT TO BURN, A CROSS OR CROSS-
8 SHAPED OBJECT ON THE PROPERTY.

9 Enacting section 1. This amendatory act does not take effect
10 unless House Bill No. 6340 of the 94th Legislature is enacted into
11 law.
