25 Sec. 601. As a condition of expenditure of fisheries

- 14 for grants to watershed councils, resource development councils,
- 15 soil conservation districts, local governmental units, and other
- 16 nonprofit organizations for stream habitat stabilization and soil
- 17 erosion control.
- 18 (2) The fisheries division of the department shall develop
- 19 priority and cost estimates for all recommended projects.
- Sec. 603. From the funds appropriated in part 1 for fish
- 21 production and fisheries resource management, the department shall
- 22 continue to operate the 6 hatcheries that were operational on
- 23 September 30, 2007.

24 PARKS AND RECREATION

- Sec. 701. Pursuant to section 1902(2) of the natural resources
- and environmental protection act, 1994 PA 451, MCL 324.1902, there

- 1 is appropriated from the Michigan natural resources trust fund to
- 2 the Michigan state parks endowment fund an amount not to exceed
- 3 \$10,000,000.00 for the fiscal year ending September 30, 2009.
- 4 Sec. 702. (1) The department shall prepare detailed reports
- 5 for construction projects in state parks that will involve campsite
- 6 or campground closures. These reports shall include expected costs,
- 7 impacts on recreation opportunities, impacts on state park
- 8 revenues, and the expected impact on state park users. The
- 9 department shall also prepare reports on average monthly campground

25 FOREST, MINERAL, AND FIRE MANAGEMENT

26 Sec. 801. In addition to the funds appropriated in part 1,

- 1 \$350,000.00 is appropriated to cover costs related to any declared
- 2 emergency involving the collapse of any abandoned mine shaft
- 3 located on state land. This appropriation shall not be expended
- 4 unless the state budget director recommends the expenditure and the
- 5 department notifies the house and senate committees on
- 6 appropriations.
- 7 Sec. 802. As a condition of expenditure of appropriations in
- 8 part 1 from state general fund/general purpose, on November 15,
- 9 2008 the department shall provide at least \$1,000,000.00 from
- 10 cooperative resources programs as an interdepartmental grant to the
- 11 department of agriculture for the cooperative resources management
- 12 initiative program for the purposes of supporting forestry programs
- in local conservation districts.
- 14 Sec. 803. The department shall spend amounts appropriated in
- 15 part 1 for forest-related activities to employ or contract for
- 16 additional foresters to mark timber, pursuant to section 804.
- Sec. 804. Of the funds appropriated in part 1, the department
- 18 shall, subject to the forest certification process, prescribe
- 19 appropriate treatment on not less than 63,000 acres at the current
- 20 average rate of 12.5 to 13 cords per acre, and offer those cords
- 21 for sale in 2009, provided that the department shall take into
- 22 consideration the impact of timber harvesting on wildlife habitat
- 23 and recreation uses. The department shall, subject to the forest
- 24 certification process, increase marking or treatment of hardwood
- 25 timber for sale and harvest by 10% over 2008 levels. In addition,
- 26 the department shall take into consideration silvicultural analysis
- 27 and report annually to the legislature on plans and efforts to
