A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1271.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1271. (1) NOT LATER THAN SEPTEMBER 1, 2007, THE

 7 AND DRINKS IN ANY PUBLIC SCHOOL:
 - (i) CHEWING GUM OR CANDY BARS.
 - (ii) A FOOD OR DRINK THAT CONSISTS OF 35% OR MORE SUGAR OR

- 2 (iii) JUICE THAT IS LESS THAN 100% REAL FRUIT OR VEGETABLE
