Polidori, Hopgood, Constan, Lemmons, Gonzales, Spade, Espinoza, Brown, Ball, Vagnozzi, Alma Smith, Clemente, Meadows, Robert Jones, Young, Condino, Ebli, Miller, Clack, Jackson, Hood, Virgil Smith and Sheltrown and referred to the Committee on Senior Health, Security, and Retirement.

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 21737.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 21737. (1) EXCEPT AS OTHERWISE PROVIDED UNDER SUBSECTION
- 2 (3) OR (4), IN ACCORDANCE WITH FEDERAL LAWS, RULES, AND
- 3 REGULATIONS, A NURSING HOME INITIALLY LICENSED AFTER OCTOBER 1,
- 4 1990 SHALL MAINTAIN A TEMPERATURE OF NOT LESS THAN 71 DEGREES
- 5 FAHRENHEIT OR MORE THAN 81 DEGREES FAHRENHEIT MEASURED 3 FEET ABOVE
- THE FLOOR AT ALL TIMES IN ALL AREAS OF A BUILDING ACCESSIBLE TO
- 7 RESIDENTS, EMPLOYEES, AND VISITORS EXCEPT FOR THE KITCHEN OR
- 8 LAUNDRY ROOM.
- 9 (2) EXCEPT AS OTHERWISE PROVIDED UNDER SUBSECTION (3) OR (4),

- 1 WITHIN 3 YEARS AFTER THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT
- 2 ADDED THIS SECTION, A NURSING HOME LICENSED PRIOR TO OCTOBER 1,
- 3 1990 SHALL MAINTAIN A TEMPERATURE OF NOT LESS THAN 71 DEGREES
- 4 FAHRENHEIT OR MORE THAN 81 DEGREES FAHRENHEIT MEASURED 3 FEET ABOVE
- 5 THE FLOOR AT ALL TIMES IN ALL AREAS OF A BUILDING ACCESSIBLE TO
- 6 RESIDENTS, EMPLOYEES, AND VISITORS EXCEPT FOR THE KITCHEN OR
- 7 LAUNDRY ROOM. UPON WRITTEN REQUEST OF THE NURSING HOME, THE
- 8 DEPARTMENT MAY GRANT AN EXTENSION OF THE TIME PERIOD FOR COMPLIANCE
- 9 UNDER THIS SUBSECTION IF ALL OF THE FOLLOWING ARE MET:
- 10 (A) UPON REVIEW OF THE NURSING HOME'S WRITTEN POLICIES AND
- 11 PROCEDURES AND EXISTING PLANS OR AGREEMENTS FOR EMERGENCY
- 12 SITUATIONS, THE DEPARTMENT DETERMINES THAT THERE ARE ADEQUATE
- 13 PROTECTIONS IN PLACE TO ENSURE THE CONTINUED SAFETY AND COMFORT OF
- 14 THE RESIDENTS WITHIN THAT NURSING HOME.
- 15 (B) BUILDING RENOVATIONS HAVE BEGUN TO BRING THE NURSING HOME
- 16 INTO COMPLIANCE WITH THIS SECTION OR THE NURSING HOME HAS
- 17 SUBMITTED, AND THE DEPARTMENT HAS APPROVED, THE NURSING HOME'S
- 18 PLANS FOR RENOVATION, REPAIR, OR REMODELING OF ITS BUILDING TO MEET
- 19 THE REQUIREMENTS OF THIS SECTION.
- 20 (3) IF A NURSING HOME IS LOCATED NORTH OF THE FORTY-FIFTH
- 21 PARALLEL OF LATITUDE, THE TEMPERATURES WITHIN THAT NURSING HOME MAY
- 22 ON RARE, BRIEF OCCASIONS, AS A RESULT OF RARE, BRIEF EPISODES OF
- 23 UNSEASONABLY HOT WEATHER, EXCEED THE UPPER RANGE OF 81 DEGREES
- 24 FAHRENHEIT. IF THE TEMPERATURE RANGE EXCEEDS 81 DEGREES FAHRENHEIT,
- 25 THE NURSING HOME SHALL MONITOR ITS RESIDENTS AND TAKE ANY
- 26 APPROPRIATE MEASURES TO ENSURE THE HEALTH, SAFETY, AND COMFORT OF
- 27 EACH RESIDENT.

- 1 (4) IF A NURSING HOME HAS A SEPARATE HEATING AND COOLING
- 2 SYSTEM FOR RESIDENT ROOMS THAT ALLOWS A RESIDENT TO CONTROL THE
- 3 TEMPERATURE IN HIS OR HER OWN ROOM, THE RESIDENT MAY MAINTAIN HIS
- 4 OR HER ROOM AT ANY LEVEL HE OR SHE DESIRES UNLESS THE TEMPERATURE
- 5 MAY ADVERSELY AFFECT THE HEALTH, SAFETY, OR COMFORT OF THE RESIDENT
- 6 OR ANY OTHER RESIDENT SHARING THAT ROOM, IN WHICH CASE THE NURSING
- 7 HOME SHALL INTERVENE AND TAKE APPROPRIATE ACTION TO KEEP THE
- 8 RESIDENT OR RESIDENTS SAFE AND COMFORTABLE. IF A RESIDENT CHOOSES
- 9 TO MAINTAIN THE TEMPERATURE IN HIS OR HER ROOM AT A TEMPERATURE
- 10 LEVEL THAT IS OUTSIDE OF THE TEMPERATURE RANGE REQUIRED UNDER THIS
- 11 SECTION, THAT RESIDENT SHALL SUBMIT DOCUMENTATION FROM HIS OR HER
- 12 PHYSICIAN APPROVING THOSE TEMPERATURE CONDITIONS. THIS
- 13 DOCUMENTATION SHALL BE INCLUDED WITH THAT RESIDENT'S CARE PLAN.
- 14 (5) WITHIN 30 DAYS AFTER THE EFFECTIVE DATE OF THE AMENDATORY
- 15 ACT THAT ADDED THIS SECTION, THE NURSING HOME ADMINISTRATOR SHALL
- 16 DEVELOP WRITTEN POLICIES AND PROCEDURES FOR MAINTAINING SAFE AND
- 17 COMFORTABLE TEMPERATURES IN THE NURSING HOME, MAINTAIN A COPY OF
- 18 THOSE WRITTEN POLICIES AND PROCEDURES ON THE PREMISES, AND SUBMIT A
- 19 COPY OF THE SAME TO THE DEPARTMENT FOR FILING WITH ITS MOST RECENT
- 20 LICENSE OR RENEWAL APPLICATION. THE WRITTEN POLICIES AND PROCEDURES
- 21 SHALL INCLUDE AT LEAST ALL OF THE FOLLOWING:
- 22 (A) MEASURES TO BE TAKEN TO ENSURE THE HEALTH, SAFETY, AND
- 23 COMFORT OF RESIDENTS IN THE NURSING HOME.
- 24 (B) IDENTIFICATION OF CIRCUMSTANCES THAT REQUIRE NOTIFICATION
- 25 OF THE NURSING HOME ADMINISTRATOR OR A PHYSICIAN AND THE
- 26 APPROPRIATE TIME FRAMES FOR THOSE ACTIONS.
- 27 (C) IDENTIFICATION OF AVAILABLE SITES WITHIN OR OUTSIDE THE

- 1 NURSING HOME TO WHICH RESIDENTS MAY BE RELOCATED IF TEMPERATURES
- 2 WITHIN THE NURSING HOME PRESENT A THREAT TO THE HEALTH OR SAFETY OF
- 3 THE RESIDENTS.
- 4 (6) A NURSING HOME SHALL HAVE AN EXISTING AGREEMENT OR PLAN
- 5 FOR EMERGENCY SITUATIONS, INCLUDING, BUT NOT LIMITED TO, AN
- 6 AGREEMENT OR PLAN FOR THE PROVISION OF EMERGENCY SERVICES AND
- 7 REPAIRS IN THE EVENT OF AN ELECTRICAL, HEATING, VENTILATION, OR AIR
- 8 CONDITIONING FAILURE OR MALFUNCTION. THE NURSING HOME SHALL
- 9 MAINTAIN A COPY OF THESE WRITTEN AGREEMENTS OR PLANS ON THE
- 10 PREMISES, AND THOSE SHALL BE MADE AVAILABLE TO THE DEPARTMENT UPON
- 11 REOUEST. REPAIR WORK THAT IS NECESSARY TO MAINTAIN THE TEMPERATURE
- 12 WITHIN THE RANGE DESCRIBED IN SUBSECTIONS (1) AND (2) SHALL BE
- 13 COMPLETED WITHIN 48 HOURS OR LESS. IF, FOR REASONS BEYOND THE
- 14 NURSING HOME'S CONTROL, REPAIRS CANNOT BE COMPLETED IN A TIMELY
- 15 MANNER, THE NURSING HOME SHALL IMPLEMENT ITS WRITTEN POLICIES AND
- 16 PROCEDURES ESTABLISHED PURSUANT TO SUBSECTION (5).
- 17 (7) WITHIN 6 MONTHS AFTER THE EFFECTIVE DATE OF THE AMENDATORY
- 18 ACT THAT ADDED THIS SECTION, THE DEPARTMENT SHALL ESTABLISH AN AIR
- 19 CONDITIONING GRANT PROGRAM FOR THE PURPOSE OF PROVIDING GRANTS TO
- 20 NURSING HOMES THAT NEED TO REPLACE, UPDATE, OR REPAIR THEIR HEATING
- 21 AND COOLING SYSTEM TO MAINTAIN THE TEMPERATURE STANDARDS
- 22 ESTABLISHED UNDER SUBSECTION (2). THE AIR CONDITIONING GRANT
- 23 PROGRAM SHALL PROVIDE GRANTS TO NURSING HOMES THAT THE DEPARTMENT
- 24 CONSIDERS ELIGIBLE WITHIN 60 DAYS AFTER THE NURSING HOME SUBMITS
- 25 DOCUMENTATION TO THE DEPARTMENT VERIFYING THAT THE HEATING AND
- 26 COOLING SYSTEM HAS BEEN REPLACED, UPDATED, OR REPAIRED TO COMPLY
- 27 WITH THIS SECTION. ANY BUILDING MAINTENANCE, REPAIR, UPKEEP, OR

- 1 REPLACEMENT WITH SIMILAR EQUIPMENT, IMPLEMENTED AS A RESULT OF THIS
- 2 SECTION, IS NORMAL BUILDING MAINTENANCE AND IS NOT A RENOVATION. IN
- 3 EACH FISCAL YEAR GOVERNED BY THIS SUBSECTION, THE DEPARTMENT SHALL
- 4 ONLY EXPEND FUNDS UNDER THE AIR CONDITIONING GRANT PROGRAM IF THE
- 5 MEDICAID REIMBURSEMENT RATES ARE NOT BELOW THE LEVEL OF RATES IN
- 6 EFFECT ON JULY 1, 2004.
- 7 (8) IN ACCORDANCE WITH SECTIONS 2262, 2263, AND 21799D, A
- 8 NURSING HOME THAT VIOLATES THIS SECTION IS SUBJECT TO A CIVIL
- 9 PENALTY.
