HOUSE BILL No. 4419

March 7, 2007, Introduced by Reps. Kathleen Law and Jackson and referred to the Committee on Government Operations.

A bill to amend 1978 PA 368, entitled

"Public health code,"

(MCL 333.1101 to 333.25211) by adding sections 2862 and 2882a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2862. (1) IN ADDITION TO THE ORIGINAL MARRIAGE LICENSE
- 2 CERTIFICATE FILED WITH THE STATE REGISTRAR UNDER SECTION 2861, THE
 - STATE REGISTRAR SHALL ISSUE, UPON REQUEST AND PAYMENT OF A FEE
- 4 ESTABLISHED BY RULE, AN HEIRLOOM MARRIAGE CERTIFICATE REPRESENTING
- 5 THE MARRIAGE OF THE INDIVIDUALS NAMED ON THE ORIGINAL MARRIAGE
- 6 LICENSE CERTIFICATE. THE STATE REGISTRAR MAY ESTABLISH PROCEDURES
- 7 FOR THE ADMINISTRATION OF AN HEIRLOOM MARRIAGE CERTIFICATE.

- 26 (6) THE GENEALOGY PROJECTS FUND IS ESTABLISHED IN THE STATE
- 27 TREASURY. THE MONEY IN THE GENEALOGY FUND SHALL BE SPENT ONLY AS
