## **HOUSE BILL No. 4823**

May 24, 2007, Introduced by Reps. Nofs, Moore, LaJoy, Rocca, Caswell, Stahl, Stakoe, Hune, Steil, Hansen, Brandenburg, Casperson, Hildenbrand, Green, Hoogendyk, DeRoche, Palmer, Wenke, Rick Jones, Gaffney, Byrum, LeBlanc, Polidori and Sheen and referred to the Committee on Intergovernmental, Urban and Regional Affairs.

A bill to amend 2004 PA 46, entitled

"Public safety officers benefit act,"

by amending the title and section 2 (MCL 28.632) and by adding section 4a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 TITLE

An act to provide compensation AND OTHER BENEFITS to dependents of public safety officers who are killed or who are permanently and totally disabled in the line of duty; to create the public safety officers benefit fund; to prescribe the duties and responsibilities of certain state officers; and to make an appropriation.

Sec. 2. As used in this act:

(a) "Commission" means the commission on law enforcement standards created under the commission on law enforcement standards

- 20 (G) (f) "Line of duty" means either of the following:
- 21 (i) Any action which an officer whose primary function is crime
- 22 control or reduction, enforcement of the criminal law, or
- 23 suppression of fires is obligated or authorized by rule,
- 24 regulations, condition of employment or service, or law to perform,
- 25 including those social, ceremonial, or athletic functions to which
- 26 the officer is assigned, or for which the officer is compensated,
