May 24, 2007, Introduced by Reps. Lahti, Alma Smith, Lindberg, McDowell, Green, Bauer, Booher, Gillard, Casperson, Sak, Rick Jones, Meekhof, Brown, Polidori, Scott, Meadows, Young, Condino, Hammel, Bennett, Espinoza and Dean and referred to the Committee on Appropriations.

A bill to authorize the state administrative board to convey certain state owned property in Gogebic county; to prescribe conditions for the conveyance; and to provide for disposition of revenue derived from the conveyance.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. The state administrative board, on behalf of the
- 2 state, may convey to Gogebic community college in Gogebic county,
- 3 for consideration of \$1.00, certain real property now under the
- 4 jurisdiction of the department of military and veterans affairs and
- 5 located in Gogebic county, Michigan, commonly known as the Ironwood
 - armory and more particularly described as:

- 1 Sec. 3. The conveyance authorized by section 1 shall provide
- 2 for all of the following:
- 3 (a) The property shall be used exclusively for educational
- 4 purposes, and upon termination of that use or upon use for any
- 5 other purpose, the state may reenter and repossess the property,
- 6 terminating the grantee's estate in the property.
- 7 (b) If the grantee disputes the state's exercise of its right
- 8 of reentry and fails to promptly deliver possession of the property
- 9 to the state, the attorney general, on behalf of the state, may
- 10 bring an action to quiet title to, and regain possession of, the
- 11 property.
- Sec. 4. The conveyance authorized by this act shall be by
- 13 quitclaim deed designed or otherwise approved by the attorney
- 14 general and shall not reserve to the state any gas, oil, or mineral
- 15 rights found on, within, or under the conveyed property, but shall
- 16 provide for the exercise of the state's ongoing property interests
- 17 in and regulatory jurisdiction over any historic artifacts and
- 18 antiquities subsequently found on the site.
- 19 Sec. 5. The revenue received from the conveyance authorized by
- 20 this act shall be deposited in the state treasury and credited to
- 21 the general fund.
