HOUSE BILL No. 4888

June 7, 2007, Introduced by Reps. Caswell, Moore, Stahl, Green, Nitz, Hansen, Nofs, Horn and Dean and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 803e (MCL 257.803e), as amended by 2003 PA 30.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 803e. (1) A person who has been a prisoner of war or a

 person whose spouse has been a prisoner of war HIS OR HER SPOUSE

 may make application APPLY to the secretary of state for a special

 registration plate which THAT shall be inscribed with special

 identification numbers preceded by the letters "EX-POW" and shall

 have the words "ex-prisoner of war" inscribed beneath the

 registration number.
 - (2) A person who was a member of the armed services during
 World War I OR HIS OR HER SPOUSE may make application APPLY to the
 secretary of state for a special registration plate , which THAT

- 1 shall be inscribed with special identification numbers preceded by
- 2 the letters "WWI" and shall have the words "World War I veteran"
- 3 inscribed beneath the registration number.
- 4 (3) A person who was a member of the armed services during
- 5 1941, stationed at a United States military or naval establishment
- 6 at Pearl Harbor in the Hawaiian islands, and who survived the
- 7 attack by Japan on Pearl Harbor on December 7, 1941 OR HIS OR HER
- 8 SPOUSE may make application APPLY to the secretary of state for a
- 9 special registration plate , which THAT shall be inscribed with
- 10 special identification numbers and shall have the words "Pearl
- 11 Harbor survivor" inscribed beneath the registration number.
- 12 (4) A person who is a recipient of the purple heart medal OR
- 13 HIS OR HER SPOUSE may make application APPLY to the secretary of
- 14 state for a special registration plate which THAT shall be
- 15 inscribed with special identification numbers and shall have the
- 16 words "combat wounded veteran" inscribed beneath the registration
- 17 number. In addition, the special registration plate described under
- 18 this subsection shall be inscribed with a vignette of the official
- 19 purple heart medal.
- 20 (5) Application for a special registration plate shall be on a
- 21 form prescribed by the secretary of state, and shall be accompanied
- 22 by any proof of the applicant OR HIS OR HER SPOUSE having been a
- 23 prisoner of war, World War I veteran, Pearl Harbor survivor, or
- 24 recipient of the purple heart medal that the secretary of state may
- 25 require. The application for a special registration plate shall
- 26 also be accompanied with payment of a \$5.00 service fee.
- 27 (6) Upon proper application and payment of the \$5.00 service

- 1 fee, the secretary of state shall issue 1 or more special
- 2 registration plates for each applicant for use on a passenger
- 3 vehicle. A person who is disabled who makes application for a
- 4 special registration plate under this section and who makes payment
- 5 of PAYS the \$5.00 service fee shall be issued a tab for persons
- 6 with disabilities as provided in section 803f for his or her
- 7 special registration plate. The secretary of state shall require
- 8 the same proof that the applicant is a disabled person as is
- 9 required for issuance of a permanent windshield placard under
- 10 section 675. One person in any household is entitled to 1 special
- 11 registration plate issued under subsection (1) that is exempt from
- 12 payment of the tax provided in section 801. The person who is
- 13 issued an additional special registration plate under subsection
- 14 (1) shall be assessed the applicable tax provided for in section
- 15 801. A person issued 1 or more special registration plates under
- 16 subsection (2), (3), or (4) shall be assessed the applicable tax
- 17 provided in section 801.
- 18 (7) The use of a special registration plate on a vehicle other
- 19 than the vehicle for which the plate is issued, or by a person who
- 20 does not qualify under this section, is a misdemeanor.
- 21 (8) The special registration plate issued under this section
- 22 expires on the birthday of the vehicle owner in a year in which new
- 23 plates are issued by the secretary of state. Application for
- 24 renewal of the special registration plate shall be accompanied by a
- 25 \$5.00 service fee. The applicant is not required to furnish the
- 26 proof provided in subsection (5).
