June 19, 2007, Introduced by Reps. Moore, Green, Hildenbrand, Shaffer, Nofs, David Law, Dean, Stahl, Steil, Horn, LaJoy, Amos, Opsommer and Huizenga and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16d of chapter XVII (MCL 777.16d), as amended
by 2005 PA 336.

CHAPTER XVII

Sec. 16d. This chapter applies to the following felonies
