## **HOUSE BILL No. 5133**

August 22, 2007, Introduced by Reps. David Law, LaJoy, Ward and Marleau and referred to the Committee on Judiciary.

A bill to amend 1994 PA 295, entitled

"Sex offenders registration act,"

by amending section 7 (MCL 28.727), as amended by 2004 PA 237.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 7. (1) A registration under this act shall be made on a
- 2 form provided by the department and shall be forwarded to the
- 3 department in the format the department prescribes, along with a
- 4 \$35.00 registration fee for each original registration, except as
- 5 otherwise provided in section 5b. A registration shall contain all
- 6 of the following:
- 7 (a) The individual's name, social security number, date of
  - birth, and address or expected address. An individual who is in a
  - witness protection and relocation program is only required to use

- 1 the name and identifying information reflecting his or her new
- 2 identity in a registration under this act. The registration and
- 3 compilation databases shall not contain any information identifying
- 4 the individual's prior identity or locale. The department shall
- 5 request each individual to provide his or her date of birth if it
- 6 is not included in the registration, and that individual shall
- 7 comply with the request within 10 days.
- 8 (b) A brief summary of the individual's convictions for listed
- 9 offenses regardless of when the conviction occurred, including
- 10 where the offense occurred and the original charge if the
- 11 conviction was for a lesser offense.
- 12 (c) A complete physical description of the individual.
- 13 (d) The photograph required under section 5a.
- 14 (e) The individual's fingerprints if not already on file with
- 15 the department. An individual required to be registered on
- 16 September 1, 1999 shall have his or her fingerprints taken not
- 17 later than September 12, 1999 if not already on file with the
- 18 department. The department shall forward a copy of the individual's
- 19 fingerprints to the federal bureau of investigation if not already
- 20 on file with that bureau.
- 21 (f) Information that is required to be reported under section
- **22** 4a.
- 23 (G) THE NAME AND ADDRESS OF EACH COMMERCIAL SOCIAL NETWORKING
- 24 SITE USED BY THE INDIVIDUAL, IF ANY. THE DEPARTMENT SHALL PROMPTLY
- 25 INFORM EACH COMMERCIAL SOCIAL NETWORKING SITE IDENTIFIED BY THE
- 26 INDIVIDUAL UNDER THIS SUBDIVISION OF THE INDIVIDUAL'S STATUS AS A
- 27 REGISTERED SEX OFFENDER AND EACH USER NAME AND ELECTRONIC MAIL

- 1 ADDRESS THE INDIVIDUAL USES AT EACH COMMERCIAL SOCIAL NETWORKING
- 2 SITE. THE INDIVIDUAL SHALL REPORT TO THE DEPARTMENT ANY CHANGE IN
- 3 INFORMATION REPORTED UNDER THIS SUBDIVISION WITHIN 24 HOURS AFTER
- 4 THE CHANGE IS MADE, AND THE DEPARTMENT SHALL PROMPTLY INFORM THE
- 5 COMMERCIAL SOCIAL NETWORKING SITE OF THE NEW INFORMATION. AS USED
- 6 IN THIS SUBDIVISION, "COMMERCIAL SOCIAL NETWORKING SITE" MEANS A
- 7 COMMERCIALLY OPERATED INTERNET WEBSITE OFFERED BY A COMMERCIAL
- 8 ENTITY THAT DOES ALL OF THE FOLLOWING:
- 9 (i) PERMITS REGISTERED USERS TO CREATE AN ON-LINE PROFILE THAT
- 10 INCLUDES DETAILED PERSONAL INFORMATION.
- 11 (ii) PERMITS REGISTERED USERS TO CREATE AN ON-LINE JOURNAL AND
- 12 SHARE THAT JOURNAL WITH OTHER USERS.
- 13 (iii) PERMITS REGISTERED USERS TO SHARE HIGHLY PERSONALIZED
- 14 INFORMATION.
- 15 (iv) ENABLES COMMUNICATION AMONG USERS.
- 16 (2) A registration may contain the individual's blood type and
- 17 whether a DNA identification profile of the individual is
- 18 available.
- 19 (3) The form used for registration or verification under this
- 20 act shall contain a written statement that explains the duty of the
- 21 individual being registered to provide notice of a change of
- 22 address under section 5, the procedures for providing that notice,
- 23 and the verification procedures under section 5a.
- 24 (4) The individual shall sign a registration, notice, and
- 25 verification. However, the registration, notice, or verification
- 26 shall be forwarded to the department regardless of whether the
- 27 individual signs it or pays the registration fee required under

- 2 (5) The officer, court, or an employee of the agency
- 3 registering the individual or receiving or accepting a registration
- 4 under section 4 shall sign the registration form.
- **5** (6) An individual shall not knowingly provide false or
- 6 misleading information concerning a registration, notice, or
- 7 verification.
- 8 (7) The department shall prescribe the form for a notification
- 9 required under section 5 and the format for forwarding the
- 10 notification to the department.
- 11 (8) The department shall promptly provide registration,
- 12 notice, and verification information to the federal bureau of
- 13 investigation and to local law enforcement agencies, sheriff's
- 14 departments, department posts, and agencies of other states
- 15 requiring the information, as provided by law.
